17 REPORTS OF THE CHIEF EXECUTIVE OFFICER

17.1 Reappointment of Member to the Brown Hill and Keswick Creeks Stormwater Board Brief

This report provides Elected Members with the recommendation from the Nominations Committee to reappoint a candidate to the Brownhill and Keswick Creeks Stormwater Board.

RECOMMENDATION

It is recommended to Council that:

1. The report be received.
2. The Nominations Committee recommendation to reappoint Mr Geoff Vogt to the Brown Hill and Keswick Creeks Stormwater Board for a period of three years be endorsed.

FURTHER

1. In accordance with Sections 91(7) and 91(9) of the *Local Government Act 1999*, the Council orders that Attachment 1 - Resume of Mr Geoff Vogt, having been considered by the Council in confidence under Section 90(3)(a), be kept confidential and not available for public inspection for a period of 12 months from the date of this meeting, on the basis that the premature disclosure of this information would be unreasonable given it contains personal information relating to the applicants which could inadvertently prejudice their future career aspirations and breach any duty of confidentiality owed to them by Council.
2. Council delegates the power of review, but not the extension, of the confidential order to the Chief Executive Officer on a monthly basis in accordance with the provisions of Section 91(9)(c) of the *Local Government Act 1999*.

Summary

At the meeting of Council held on 1 August 2017, Council endorsed the establishment of a Nominations Committee, comprising a representative from each of the five (5) Constituent Councils, to select the five (5) independent and skills based members for the Brown Hill and Keswick Creeks Stormwater Board.

The Nominations Committee, representing the Cities of Adelaide, Burnside, Mitcham, Unley and West Torrens, and having followed the agreed process, provides a recommendation for the reappointment of a member to the Brown Hill and Keswick Creeks Stormwater Board.

Background

The Brown Hill Keswick Creek (BHKC) Stormwater Project is a collaborative effort by the councils of Adelaide, Burnside, Mitcham, Unley and West Torrens, to mitigate significant flood risks and assist in safeguarding properties across the catchment of the Brown Hill and Keswick Creeks.

In order to manage the catchment, the Constituent Councils adopted the 2016 Stormwater Management Plan (the Plan) for the four major water courses of Brown Hill, Keswick, Glen Osmond and Parklands Creeks. The primary objective of the Plan is to mitigate the risk and reduce the impact of major flooding on properties within the BHKC catchment, up to and including a 100-year average recurrence interval (ARI) flood.

To co-ordinate the implementation of the Plan, the Constituent Councils endorsed a draft BHKC Regional Subsidiary Charter, subsequently submitted to the Honourable Geoff Brock, Minister for Local Government. The Subsidiary Charter was approved by the Minister and listed within the Government Gazette on February 27, 2018. The Regional Subsidiary came into existence as of that date, pursuant to s43 of the *Local Government Act 1999* (the Act), and to be governed by a Board of Management (the Board).

The Members of the Board of Management were appointed on 3 August 2018.

Pursuant to clause 8 of the Charter, the first appointments to the Board were differential to ensure that no more than two of the terms of office of Board Members will expire at any one time.

In accordance with clause 7 of the Charter, the Constituent Councils must appoint Board members from recommendations made by the Nominations Committee.

Clause 33 of the Charter defines 'Nominations Committee' as the Chief Executive Officers (or their nominees) and the Mayor (or elected member authorised by the Mayor) of each of the Constituent Councils. A meeting of the Nominations Committee for any purpose provided in the Charter may only occur if at least three (3) of the Constituent Councils are represented by either of the CEO (or nominee) or Mayor (or elected member).

Clauses 7.3.1 and 7.3.2 of the Charter specify that Board membership is comprised as follows:

- 7.3.1 Five (5) natural persons appointed jointly by the Constituent Councils being persons who are not members or officers of any of the Constituent Councils. These persons will be appointed by the Constituent Councils from recommendations made by the Nominations Committee.
- 7.3.2 The persons recommended for appointment under clause 7.3.1 will be determined through a process approved by the Nominations Committee and will comprise persons with demonstrable skills relevant to the purpose of the Regional Subsidiary which may include (but is not limited to) skills in:
 - a) corporate financial management;
 - b) corporate governance;
 - c) project management;
 - d) general management;
 - e) engineering;
 - f) economics; or
 - g) environmental management.

The Charter sets out that the Board's membership is to comprise of five (5) natural persons who are not members or officers of any of the Councils. The Nominations Committee is to determine the process for the selection of candidates to represent the following skill sets:

- corporate financial management;
- corporate governance;
- project management;
- general management;
- engineering;
- economics; or
- environmental management.

Discussion

The current Board Members and their terms of office are as follows:

- Geoff Vogt Board Member 1-year term expiring 2nd August 2019
- Paul Bowler Board Member 2-year term expiring 2nd August 2020
- Rachel Barratt Board Member 2-year term expiring 2nd August 2020
- Judith Choate Chairperson 3-year term expiring 2nd August 2021
- Paul Gelston Board Member 3-year term expiring 2nd August 2021

Geoff Vogt's term on the Board expired on 2 August 2019. It is therefore necessary for a new board member to be appointed, or alternatively, for Geoff to be reappointed. Geoff has nominated for reappointment.

The Nominations Committee (the committee) consisting of representatives from the five constituent Councils and the Subsidiary Project Director met on 11 July 2019 to discuss Geoff Vogt's term on the Board expiring.

At the meeting it was noted that in order to maintain differential appointments with no more than 2 board positions expiring at any one time, this term of appointment will be for 3 years.

Committee members were provided with details of the current board members, their experience and expiration dates of the current terms.

A majority vote by the Nominations Committee resulted in favour of reappointing Geoff Vogt for a further term of 3 years, expiring 2 August 2022. It was a 4:1 majority with the 1 voting against recommending that the vacancy be advertised on the open market, specifically targeting someone with Finance and Governance skills. It was also recommended at the meeting that Geoff's Board position be extended temporarily pending the outcome of the formal process. All attendees were in favour of this temporary extension.

It was agreed that the detail of the discussions and which Councils voted for and against should remain confidential to encourage robust discussion in future Nominations Committee meetings.

Future processes for the Nominations Committee will be streamlined including:

- Preparation of a Terms of Reference for the Nominations Committee.
- Distribution of information to the Nominations Committee including CV of the candidate well in advance of the expiration date to allow for a market-based process if required.
- A process for the Board to assess their own performance collaboratively and to self-assess individually on an annual basis and provision of outcomes to the OEC.
- A process for capturing feedback and recommendations from the Chairperson and other Board Members and provision of this information to the Nominations Committee with the agenda.

Conclusion

This report provides Members with the recommendation from the Nominations Committee to reappoint a candidate to the Brownhill and Keswick Creeks Stormwater Board.

17.2 Glandore Character Development Plan Amendment

Brief

This report seeks to discontinue the Glandore Character Protection Development Plan Amendment (DPA) for reasons outlined in the report.

RECOMMENDATION

It is recommended to Council that:

1. The Glandore Character Protection Development Plan Amendment (DPA) be discontinued due to time constraints and ambiguity presented by the Planning Reform, along with resourcing and financial costs without a guarantee that the DPA will be successful.
2. The Administration seeks to proactively influence the Planning and Design Code to consider the impact of higher density development on Character Areas by highlighting the anomaly that has occurred through the existing definition of 'adjacent land' in the *Development Act 1993*.
3. It writes to the Minister for Planning advising that the Glandore Residential Character Protection Development Plan Amendment be discontinued due to cost, resourcing and planning reform timelines. In addition, highlight the anomaly the Glandore Residential Character Protection Development Plan Amendment sought to rectify and seek that this be remedied within the Planning and Design Code.

Introduction

In April 2016, the Parliament of South Australia passed the *Planning, Development and Infrastructure Act 2016* (PDI Act). The PDI Act is replacing the *Development Act 1993* in a series of stages, with some elements already switched on and to be totally enacted by 1 July 2020. The PDI Act establishes a new planning framework and legislative tools including some changes to definitions.

In the midst of these changes there was concern about a number of issues with regard to the interface between the Character Zone of Glandore with the Urban Corridor Zone on the southern side of Anzac Highway. So much so that at its 7 November 2017 meeting, Council resolved:

"That the Administration urgently develops a statement of intent for submission to the Minister for Planning to amend the relevant sections of Council's Development Plan, with regard to Anzac Highway, Glandore to:

- a) Ensure the community intent of the plan is reflect, as heavily consulted in 2013 and subsequently approved by the Minister for Planning in 2015.*
- b) Specify that the maximum height limit is 3 storeys for **all** land in the Urban Corridor Zone between Beckman Street and South Road, to protect the Character of the Glandore Character Policy Area 24.*
- c) Strengthen the wording with regard to the maximum height limits to ensure the relevant authority gives strong regard to the maximum height limit when considering any development application."*

In line with this resolution, a Statement of Intent (SOI) was drafted to initiate a Development Plan Amendment (DPA) to address the conflicting policy at the Urban Corridor/Glandore Character Area interface in Glandore. The SOI was supported by the Minister with some amendments which were incorporated.

As such, Council commenced a Development Plan Amendment (DPA), seeking to change policy within Council's Development Plan. Progress on the DPA has been impacted by the requirement to response to a significant number of discussion papers, legislation and other documents released by the State Planning Commission and DPTI and the lack of clarity around timing of the Planning and Design Code draft.

Of note, the Development Plan will be redundant following the enactment of the *PDI Act* and ultimately, the implementation of the State-wide Planning and Design Code (Code). The process of undertaking a DPA of this nature is, to some extent, being undermined by the planning reform underway at this point in time.

More recently the State Planning Commission (SPC) released a heritage and character position paper which identified that character areas such as the Glandore Policy Area will be captured in a character overlay with the policy for both the relevant zone and character overlay yet to be released. However, questions remain as to how the interface between character areas and new development will be treated in the policy which currently is an unknown.

Discussion

The purpose of the Glandore Character Policy Area Protection DPA is to resolve an anomaly that has been identified as giving rise to potentially detrimental impacts on the Glandore Character Policy Area (Policy Area 24 within the West Torrens Council Development Plan) from development within the Urban Corridor Zone. In particular, the DPA proposed to remedy inconsistencies in language arising from the use of the terms, abutting and adjacent in a way that almost considers the two terms interchangeable, by reviewing the wording used to enable relevant Principles of Development Control (PDC) to be interpreted in accordance with Council's original intent.

To date, the Administration have commenced the DPA process, however the process has been complicated by the state-wide planning reforms that are underway. Notably, the planning reform has redefined the term "adjacent land" via *the Planning, Development and Infrastructure Act 2016*, which when enacted for metropolitan Adelaide on 1 July 2020 will be taken to mean:

adjacent land in relation to other land, means land that is no more than 60 metres from the other land

In lieu of the definition under the *Development Act 1993*, as per below:

adjacent land in relation to other land, means land

- (a) that abuts on the other land; or
- (b) that is no more than 60 metres from the other land and is directly separated from the other land only by:
 - (i) a road, street, footpath, railway or thoroughfare; or
 - (ii) a watercourse; or
 - (iii) a reserve or other similar open space

The significance of this change to the definition is that it increases the catchment of properties that would be considered adjacent, by omitting "*adjacent land in relation to other land, means land that abuts on the other land*". When this provision is applied, the 60 metres does not extend beyond abutting properties as it would with the new definition. If Principle of Development Control 13, as below for *Urban Corridor Zone* was to transition to the Planning and Design Code, the anomaly would not be resolved unless the provision changed abutting to adjacent in the relevant Policy Area:

Building Height

Except where airport building height restrictions prevail, or the interface height provisions require a lesser height, building heights (excluding any rooftop mechanical plant or equipment) should be consistent with the following parameters:

Policy area	Maximum building height (above natural ground height)
Boulevard Policy Area 34	Allotments abutting Residential Character Glandore Policy Area 24, and allotments between Syme Street and South Road: 3 storeys and 12.5 metres All other allotments: 8 storeys and up to 32.5 metres

The Planning and Design Code, as it relates to West Torrens and the whole of Metropolitan Adelaide, is yet to be released and a consultation draft is not anticipated to be released until October 2019. It is proposed that the Minister for Planning and the Code Team at DPTI be formally advised of this anomaly in writing.

The purported purpose of the Code is to provide consistency across the State, which will see a rationalisation of Zones with DPTI anticipating that from the approximately 1500 zones in the current system, there will be less than 50 zones.

Given all of the above, there appears to be little benefit in attempting to further progress the DPA and that it be discontinued particularly given:

- The high financial and staff resourcing costs associated with progressing the DPA when, in the Administration's opinion, it is unlikely to succeed; and
- There is no guarantee that once completed, the DPA would be transitioned to the Code.

Notwithstanding the above rationale, the Administration will continue to proactively seek to solicit the same outcome within the Code as a DPA would have sought through providing rationale and highlighting the existing anomaly and seeking changes be made to ensure better interface provisions are included within the Code for interface between character residential development and medium to high rise development.

It is anticipated that this method can be achieved in a more cost efficient and timely way, therefore providing the chance of influencing the Code outcomes.

Conclusion

This report seeks to discontinue the Glandore Character Protection DPA on the basis that there is insufficient certainty around the process of transition of the Development Plan to the Code to justify financial and staffing resources where resourcing may be more effectively directed to proactively influencing the Code and planning reform to achieve the same ends in a more effective timeframe.

It is considered that the anomaly which triggered the DPA may be rectified by virtue of change of definition to adjacent land.

17.3 AdaptWest in Action

Brief

An update on the *AdaptWest in Action* climate change program is provided as part of this report, which includes the 3-year Action Plan (draft) and regional policy position on the planning reform (draft) for endorsement.

RECOMMENDATION

It is recommended to Council that:

1. The *AdaptWest in Action 2019-2022 Plan (draft)* is endorsed.
2. The actions in the plan are implemented, subject to available budget.
3. The AdaptWest Position Statement on the State Planning Reform and the Planning and Design Code (draft) is endorsed for forwarding to the Minister for Planning.

Introduction

The Cities of West Torrens, Charles Sturt and Port Adelaide Enfield are working in partnership to implement key initiatives through AdaptWest to ensure our community, environment, businesses and industries of the Western Adelaide Region remain productive, connected and can respond positively to the challenges and opportunities presented by a changing climate.

The *AdaptWest Climate Change Adaptation Plan* was endorsed by all three councils in October 2016 after extensive engagement with State and Federal government agencies, communities from each council, industry, peak bodies and research institutions.

Now in the implementation phase, the AdaptWest in Action 2019-2022 Plan (**draft - Attachment 1**) has been developed to guide implementation of programs and activities across the region over this 3-year horizon. In addition to this, a *Position Statement on the State Planning Reform - Planning and Design Code (draft - Attachment 2)* is also presented for consideration to call for more regional collaboration on shared advocacy priorities, as identified at the Elected Member workshop held earlier this year.

Discussion

The *AdaptWest in Action Plan 2019-2022 (draft)* (the Plan) is presented to Council for endorsement. The Plan and Position Statement have already been endorsed by the City of Port Adelaide Enfield and City of Charles Sturt.

The Plan is the result of extensive engagement with staff and Elected Members across the three councils. This has included a joint Elected Member workshop held on 6 March 2019, and a series of workshops with the Administration between October and December 2018.

The priority climate change adaptation options and major themes which frame the Plan were set in the AdaptWest Regional Climate Change Adaptation Plan, approved by the partner Councils in late 2016.

Projects in the Plan have been staged over a 3 year period spanning 2019-2022. This staging has been informed by:

- an assessment of the capacity of the Regional Coordinator and Administration to deliver on the Plan's priorities.
- alignment with and leveraging off existing associated programs and initiatives and activities being delivered by the three council's; and
- the existing program budget and available funding.

Funds will also be leveraged through applying for grant funding opportunities throughout the year and opportunities to partner with research organisations will also be pursued where appropriate.

The AdaptWest Steering Committee, which is comprised of members of Executive Management and Management from across the three councils, reviewed the Plan prior to it being presented to Council for endorsement.

The City of Charles Sturt manages the program budget on behalf of the partner councils. Budget reports are presented at the quarterly Steering Committee meetings.

The current allocated program budget for 2019/20 project priorities includes:

- \$120,000 for the employment of the 0.8 FTE Regional Coordinator and seed funding for an assessment of each council's governance of climate change risk
- \$10,000 for the preparation of a regional communication and marketing plan (carried forward from 2018/19)
- \$30,000 for the AdaptWest Residential Building Retrofit Project. The project is an extension of the heat island mapping that was completed in 2017. By correlating known heat islands in the region with layers of social vulnerability and tree canopy cover, we will work with partner agencies to target specific intervention at a household level.
- \$21,000 of grant funding from the National Disaster Resilience Program which was secured to complete Phase 1 of the Residential Building Retrofit Project as described above. This includes the design and pilot testing of a delivery model and scoping of local governments and other service providers roles in the model.

Other priority projects in 2019/20 include the completion of the following research projects:

- Smart irrigation trial in conjunction with SA Water. This project aims to quantify the duration and zone of effect in the use of environmental watering to assist in cooling the urban environment prior to days of forecasted extreme heat. This includes a trial site (and control site) in each council. In the City of West Torrens this is located along the Westside Bikeway.
- A research collaboration with Macquarie University to investigate the role of urban yards and trees in mitigating Western Adelaide's urban heat. This nationally significant project has been made possible due to the high quality data collected through the heat mapping project.

AdaptWest Policy Position on the Planning Reform and Design Code

The Policy Position (draft) delivers on the following adaptation priorities of The Plan:

- increase urban greenness
- plan and design climate resilient buildings, places and spaces
- manage urban runoff to mitigate flood risk and improve water quality and reuse; and
- coastal protection measures.

The joint policy position responds to the call for more regional collaboration on shared advocacy priorities, which was identified at the AdaptWest Elected Member workshop held on 6 March 2019. The draft policy position has been informed by issues raised by the three councils in previous submissions on the planning reform.

There are no new budget requests associated with this report. Implementation of the AdaptWest in Action 2019-2022 Action Plan will be subject to the partner council's annual budget processes and success in securing external funding and collaboration with other stakeholders.

Two funding matters that may need to be considered by the partner councils at a future date are:

- additional funding that may be required for the corporate risk and governance assessment, and
- ongoing funding for the Regional Coordinator Position (currently funded until June 2020).

Conclusion

This report provides an update on priority projects for the AdaptWest in Action program in 2019/20, and includes the AdaptWest in Action 2019-2022 Action Plan (draft) and AdaptWest Regional Policy Position on the State Planning Reform and Planning and Design Code (draft) for endorsement.

PROJECT SUMMARY INFORMATION

ITEM

SA WATER – SMART IRRIGATION TRIAL
 Project aims to quantify the use of environmental water used to irrigate public open space prior to heat wave conditions in order to quantify both soil moisture profiles and air temperature cooling effect (duration and distance from watered location). Concept could result in irrigation being used to create public open space cool refuges during extreme heat conditions and more efficient / cost effective watering strategies for council green assets.

MACQUARIE UNIVERSITY – INVESTIGATING THE ROLE OF URBAN YARDS AND TREES IN MITIGATING WESTERN ADELAIDE'S URBAN HEAT
 Research project aimed at extending the investment region has made in urban heat mapping. Outcome will analyse effect that local (household level) vegetation has on the cooling potential during extreme heat conditions. Aim will be to inform policy development around retaining vegetation at point of development, supporting canopy enhancement and planting guidelines.

INTEGRATION AND CORRELATION OF SA GOVERNMENT LIDAR* DATASET WITH URBAN HEAT ISLAND MAPPING
 The State Government has used LIDAR to create a detailed 3D map of metropolitan Adelaide. Post processing of this data can show vegetation type, height, and density. Correlation of this data against the UHI mapping can demonstrate the effect that vegetation has on local heat islanding. This can then be used to inform a decision support methodology as to where additional planting is required in public realm – areas of high heat exposure, and the effect that local vegetation structure has on heat island conditions.
* Lidar is a surveying method that measures distance to a target by illuminating the target with pulsed laser light and measuring the reflected pulse with a sensor. Differences in laser return times and wavelengths can then be used to make digital 3-D representations of the target. (en.wikipedia.org/wiki/Lidar)

NDRP - ADAPT WEST IN ACTION - RESIDENTIAL BUILDING RETROFIT FOR CLIMATE ADAPTATION STAGE 1
 Stage 1 aims to determine the capacity of the region, involving the AdaptWest member councils and identified private and public sector partners, to deliver targeted building upgrades to vulnerable households in the AdaptWest region. Those upgrades would be designed to reduce exposure of vulnerable residents to extreme heat.
 The output from Stage 1 will include a detailed budget and implementation plan for the subsequent (and as of yet unfunded) stages of the project. These subsequent stages may include, for example, a pilot implementation phase whereby the model (or models) identified within Stage 1 is delivered at a smaller scale, allowing its effectiveness to be tested in the Western Adelaide region. Alternatively, a full roll-out may be proposed if sufficient evidence is available to support this approach.

AdaptWest in Action - Position Statement

The Cities of Charles Sturt, Port Adelaide Enfield and West Torrens are working together to improve our region's resilience to climate change, through our AdaptWest program.

We seek to respond positively to climate change by partnering with the State Government and others to reduce the vulnerability of residents and businesses in Western Adelaide.

Our Councils recognise that the detailed content of the Planning and Design Code / State Planning Policy reforms is crucial in supporting this outcome.

We support the following, and seek their inclusion in reforms:

1. Apply the region's urban heat mapping as an overlay in the Planning and Design Code, to inform all new development
2. Increase protection for trees and green spaces that provide canopy contribution in both private and public open space including Deemed to Satisfy provisions
3. Incorporate integrated hazard mapping as part of planning assessment (including overlays for coastal, sea-level rise, flooding, heat exposure and fire risk)
4. Ensure that policy for urban infill zones incorporate a requirement for sustainable design
5. Adopt a clear set of planning policies and regulations including Deemed to Satisfy provisions for the incorporation of Water Sensitive Urban Design (WSUD) at all levels of development
6. Consider solar access impacts in the assessment of all new developments
7. Improve energy efficiency compliance requirements to account for future climate projections and require construction of climate resilient buildings
8. Incorporate climate change considerations into housing stock for vulnerable residents, including the need for effective protection during extended heat waves
9. Rezoning for urban renewal should only be considered in suitable locations and when accompanying good design and infrastructure coordination mechanisms are provided.

We recognise that, in securing these outcomes, mechanisms including careful spatial planning through the development of more detailed Regional Plans must be established to resolve and reconcile tensions between competing community desires and needs.

- Work together to set, implement and strengthen canopy targets through both Green Adelaide, planning policy in the Planning and Design Code and regulation
- Measures to improve the protection of existing canopy that falls outside of significant or regulated trees to mitigate and adapt to extreme heat conditions
- Support for targets set under Green Adelaide for increasing canopy cover and the contribution that trees within private open space have in meeting these targets
- Ensure that species diversity is prioritised and promoted to safeguard that our canopy will be resilient to future projected climate change
- Recognise the role of WSUD, permeable surfaces and associated soil health in mitigating extreme heat conditions and providing storm water management service
- Work together to set and implement planning policies to require Water Sensitive Urban Design (WSUD)
- Support and advocate for changes in the National Construction Code to better address heatwave impact through material choice, energy efficiency, permeable surfaces, deep root zones and green infrastructure
- Acknowledge the need for coastal zone provisions regarding sea level rise to be reflected in the Planning and Design Code, with relevant coastal hazards to be mapped in a spatial overlay and the use of consistent, easily interpreted requirements such as building setbacks and site and finished floor levels
- Include heat maps and canopy coverage as Overlays in the Planning and Design Code
- Provide support to the ongoing work of AdaptWest in reducing the vulnerability of residents in Western Adelaide using green infrastructure, WSUD implementation, building standards and coastal risk issues, heat island mitigation and energy efficiency measures
- Work with the Western Adelaide region to set relevant targets in relation to the above with associated strategic actions that are strengthened over time and within:
 - State Planning Policy Reforms
 - Coast Protection Agencies
 - Green Adelaide Agenda
 - The strategic plans of Western Region Councils.

PEACE DECLARATION

August 6, 2019

Around the world today, we see self-centered nationalism in ascendance, tensions heightened by international exclusivity and rivalry, with nuclear disarmament at a standstill. What are we to make of these global phenomena? Having undergone two world wars, our elders pursued an ideal—a world beyond war. They undertook to construct a system of international cooperation. Should we not now recall and, for human survival, strive for that ideal world? I ask this especially of you, the youth who have never known war but will lead the future. For this purpose, I ask you to listen carefully to the *hibakusha* of August 6, 1945.

A woman who was five then has written this poem:

Little sister with a bowl cut / head spraying blood
embraced by Mother / turned raging Asura

A youth of 18 saw this: “They were nearly naked, their clothes burned to tatters, but I couldn’t tell the men from the women. Hair gone, eyeballs popped out, lips and ears ripped off, skin hanging from faces, bodies covered in blood—and so many.” Today he insists, “We must never, ever allow this to happen to any future generation. We are enough.” Appeals like these come from survivors who carry deep scars in body and soul. Are they reaching you?

“A single person is small and weak, but if each of us seeks peace, I’m sure we can stop the forces pushing for war.” This woman was 15 at the time. Can we allow her faith to end up an empty wish?

Turning to the world, we do see that individuals have little power, but we also see many examples of the combined strength of multitudes achieving their goal. Indian independence is one such example. Mahatma Gandhi, who contributed to that independence through personal pain and suffering, left us these words, “Intolerance is itself a form of violence and an obstacle to the growth of a true democratic spirit.” To confront our current circumstances and achieve a peaceful, sustainable world, we must transcend differences of status or opinion and strive together in a spirit of tolerance toward our ideal. To accomplish this, coming generations must never dismiss the atomic bombings and the war as mere events of the past. It is vital that they internalize the progress the *hibakusha* and others have made toward a peaceful world, then drive steadfastly forward.

World leaders must move forward with them, advancing civil society’s ideal. This is why I urge them to visit the atomic-bombed cities, listen to the *hibakusha*, and tour the Peace Memorial Museum and the National Peace Memorial Hall to face what actually happened in the lives of individual victims and their loved ones. I want our current leaders to remember their courageous predecessors: when nuclear superpowers, the US and USSR, were engaged in a tense, escalating nuclear arms race, their leaders manifested reason and turned to dialogue to seek disarmament.

This city, along with the nearly 7,800 member cities of Mayors for Peace, is spreading the Spirit of Hiroshima throughout civil society to create an environment supportive of leaders taking action for nuclear abolition. We want leaders around the world to pursue negotiations in good faith on nuclear disarmament, as mandated by Article VI of the Nuclear Non-Proliferation Treaty, and respond to the yearning of civil society for entry into force of the Treaty on the Prohibition of Nuclear Weapons (TPNW), a milestone on the road to a nuclear-weapon-free world.

I call on the government of the only country to experience a nuclear weapon in war to accede to the *hibakusha*’s request that the TPNW be signed and ratified. I urge Japan’s leaders to manifest the pacifism of the Japanese Constitution by displaying leadership in taking the next step toward a world free from nuclear weapons. Furthermore, I demand policies that expand the “black rain areas” and improve assistance to the *hibakusha*, whose average age exceeds 82, as well as the many others whose minds, bodies and daily lives are still plagued by suffering due to the harmful effects of radiation.

Today, at this Peace Memorial Ceremony commemorating 74 years since the atomic bombing, we offer our heartfelt consolation to the souls of the atomic bomb victims and, in concert with the city of Nagasaki and kindred spirits around the world, we pledge to make every effort to achieve the total elimination of nuclear weapons and beyond that, a world of genuine, lasting peace.

Nagasaki Peace Declaration

Close Your Eyes and Listen

While thousands of arms and legs were torn off
Intestines drooping out
Maggots swarming in bodies,
Those still breathing searched for loved ones
And cremated the dead they found.
The smoke of burning corpses rose into the sky
And innocent blood stained the water of Urakami River.

Leaving only keloid scars, the war finally came to an end.

But
My mother and father are gone.
My brothers and sisters will never return.

People are weak and quick to forget;
They repeat the same mistakes again and again.

But
This one thing must never be forgotten.
This one thing must never be repeated
Under any circumstances whatsoever...

This poem was written by a woman exposed to the Nagasaki atomic bombing at 11:02 a.m., August 9, 1945. Seventeen years old, she lost her family and suffered serious injuries. The poem expresses her fervent belief that no one else in the world should ever have to experience the same tragedy.

The atomic bombs were built by human hands and exploded over human heads. It follows that nuclear weapons can be eliminated by an act of human will and that the source of that will is, without question, the mind of each human being.

The present world situation involving nuclear weapons is extremely dangerous. The opinion that nuclear weapons are useful is once again gaining traction. The United States is developing smaller, more manageable nuclear weapons, and Russia has announced the development and deployment of new nuclear weaponry. Moreover, the Intermediate-Range Nuclear Forces (INF) Treaty that ended the cold war arms race is facing dissolution, just as the continuation of the Strategic Arms Reduction Treaty (New START) is imperiled. The achievements of humankind and the results of our longstanding efforts to rid the world of nuclear weapons are collapsing one after another, and the danger of a nuclear calamity is mounting.

Have the desperate appeals of the atomic bomb survivors, endeavoring to ensure that the living hell caused by nuclear weapons is "never repeated," failed to reach the ears of the world?

The answer is no. There are many people in the United Nations, in governments and municipalities, and especially in civil society groups including the atomic bomb survivors who share the same opinion and are speaking out.

As a collection of small voices, civil society groups have shown the power time and again to change the world. The testing of hydrogen bombs in the Bikini Atoll in 1954 stirred up a wave of protests that swept across the globe and resulted in the conclusion of test ban treaties. Similarly, the power of citizens movements played an important role in the conclusion of the

Treaty on the Prohibition of Nuclear Weapons in 2017. The power of a single individual is small but by no means weak.

I call out to civil society throughout the world.

Let us continue to discuss our experiences of war and the atomic bombings and pass the information on to future generations. Knowledge of the horror of war is an important first step to peace.

Let us continue to promote trust between people across country borders. The bridges of trust built by individuals will help to prevent the outbreak of war due to national conflicts.

Let us inform our children about the importance of understanding the pain of others. That will sow the seeds of peace in children's hearts.

There are many things that we can do in the cause of peace. Let us avoid despair and indifference and continue to cultivate a culture of peace. Let us raise our voices and insist that nuclear weapons are unnecessary.

This is the big role that all of us can play, however small we may seem.

Leaders of the world. Visit the atomic-bombed cities and see, hear and feel what happened under the mushroom cloud. Imprint in your minds the inhumanity of nuclear weapons. Leaders of the nuclear states. The Treaty on the Non-Proliferation of Nuclear Weapons (NPT) will reach its fifty-year milestone next year. All the nuclear states should recall the meaning of the treaty, which promises to eliminate nuclear weapons and compels each country to fulfill that duty. I appeal to the United States and Russia, in particular, to assume responsibility as nuclear superpowers by demonstrating to the world concrete ways to drastically reduce nuclear stockpiles.

I also appeal to the Japanese government. Japan has turned its back on the Treaty on the Prohibition of Nuclear Weapons. As the only country in the world to have experienced the devastation caused by nuclear weapons, Japan must sign and ratify the Treaty on the Prohibition of Nuclear Weapons as soon as possible. As a means to that end, I ask Japan to seize the trend toward denuclearization on the Korean Peninsula and to initiate efforts to make northeast Asia a nuclear-free zone where all countries coexist under, not a "nuclear umbrella," but a "non-nuclear umbrella." And above all, I ask the Japanese government to uphold the spirit of "never resort to war" enshrined in the Japanese Constitution and to take the lead in disseminating that spirit around the world.

The average age of the atomic bomb survivors has exceeded 82. I ask the Japanese government to adopt further measures to support the aging survivors and take steps to assist the people who were exposed to the atomic bombings but are yet to be recognized as survivors.

As a city exposed to nuclear devastation, Nagasaki will continue to support the people of Fukushima, who are still struggling with radioactive contamination eight years after the nuclear power plant disaster.

My heartfelt thoughts go out to the people who perished in the atomic bombing, and I declare Nagasaki's determination, along with Hiroshima and people everywhere committed to peace, to strive relentlessly for the abolition of nuclear weapons and the realization of lasting world peace.

11.4 Mendelson Foundation Investment Performance 2018/19

Brief

This report provides information on the investment performance of the Mendelson Foundation for the 12 months ending 30 June 2019, pursuant to the requirements of Section 140 of the *Local Government Act 1999*.

RECOMMENDATION

The Committee recommends to Council that the report be received.

Introduction

Section 140 of the *Local Government Act 1999* states that Council must, at least once in each year, review the performance of its investments. This report deals with the investments of the Mendelson Foundation.

Discussion

Investments of the Mendelson Foundation are governed by the *Mendelson Foundation Investments Policy*, most recently updated in November 2014. This policy covers areas such as legislative requirements and obligations, approved asset allocation, policy regarding exposure, and reporting obligations.

During 2018/19, FMD Financial / Paragem Pty Ltd (AFSL No. 297276) was the investment adviser to Council in relation to the Mendelson Foundation.

After allowing for the withdrawal of funds, the assets of the Mendelson portfolio increased by 9.5 per cent in 2018/19. This compares with an increase of 8.1 per cent in 2017/18, an increase of 13.0 per cent in 2016/17 and a fall of 1.8 per cent in 2015/16.

The Mendelson portfolio benefited from solid returns in the Australian and International shares sectors. Falls in interest rates provided a stimulus for financial and interest rate sensitive stocks, increases in commodities prices lifted the share prices of resources stocks and share market momentum continued to drive strong increases in the price of growth stocks in healthcare and technology sectors.

Over the longer term, the Mendelson portfolio continues to perform well and generate a real return ahead of inflation. FMD has provided the following benchmark information:

Because the Mendelson portfolio currently has around 30 per cent invested in “defensive” assets and 70 per cent in “growth” assets, the balanced index is the more appropriate “like-for-like” comparison above. The moderate index is a little more conservative than this benchmark.

The above table illustrates that the Mendelson portfolio outperformed the balanced index over the last 1, 3 and 5 years.

In addition, and most noteworthy, the Mendelson portfolio has funded over \$200,000 in scholarships over the last 5 years while still continuing to increase in value over time.

As at 30 June 2019, the total value of the portfolio was \$1,531,414 (\$1,398,314 at 30 June 2018).

The following table shows the approved “asset allocation” for the Mendelson Foundation as per Council policy guidelines, compared with the actual allocation at 30 June 2019:

As shown by the table, the asset allocation for the Mendelson Foundation conforms with policy limits for defensive investments and particularly, growth investments.

In 2018/19, the Mendelson Foundation has maintained a well-diversified portfolio and maintained growth investments within the approved limit through selective trimming of share positions and investing the proceeds in defensive investments such as the listed MCP Income Trust.

In other respects, the Mendelson Foundation continues to conform with Council policy. For Australian shares, policy states that a reasonable range of industry sectors must be used in order to minimise the risks inherent in any given sector. Policy also states that property investments must be via listed property trusts / managed funds while investments in international shares must be via managed funds. The Mendelson Foundation continues to conform to these requirements.

The table following shows the spread of the investment portfolio over investment categories/sectors:

Conclusion

The Mendelson Foundation portfolio value increased strongly in 2018/19 during a period of rising share markets both locally and overseas. Over the longer term, the portfolio continues to perform well with positive returns above inflation and in excess of three and five year benchmark returns for similar “balanced funds”.

In 2018/19, the Mendelson investments continued to be actively managed by the Committee.

From a compliance perspective, the Mendelson Foundation remains in conformity with Council's approved policy limits on asset allocation, policy on use of managed funds for property and international investments and policy relating to diversity of share investments.

11.5 Investment Review 2018/19

Brief

This report provides a review of Council investments for 2018/19, pursuant to the requirements of Section 140 of the *Local Government Act 1999*.

RECOMMENDATION

Introduction

A review of Council investments for 2018/19 is provided in this report, pursuant to the requirements of Section 140 of the *Local Government Act 1999*.

Discussion

Working Account

Balances in Council's working account with the Commonwealth Bank were kept to a minimum throughout the 2018/19 financial year, except for short peak rate receipting periods, with these ranging from -\$48,549 to \$5.492 million.

Interest of \$8,949 (\$8,547 in 2017/18) was received during the year, with interest rates reducing from 0.75 per cent to 0.50 per cent in June 2019.

Business Online Saver Account (BOS)

Council has operated a business on-line saver account with the Commonwealth Bank since December 2008. The interest rate on this account fell from 1.00 per cent in July 2018 to 0.70 per cent in June 2019. The account held deposits of \$13,958 in July 2018, and the only movements being interest received left a closing balance of \$14,076 in June 2019. The balance in this account was kept to a minimum due to higher interest rates being available from the LGFA.

Interest of \$127 was received on this account during the year (\$2,701 in 2017/18).

Local Government Finance Authority

During 2018/19 the Local Government Finance Authority (LGFA) offered interest rates on 24 hour call deposits at the RBA official cash rates. The rate remained at 1.5 per cent for the whole year, in line with RBA movements until June 2019 when the interest rate dropped to 1.25 per cent. During 2018/19 Council's 24 hour call account balance with the LGFA moved from \$10,283,449 in July 2018 to \$4,047,628 in June 2019.

During 2018/19 Council also held additional term deposits with the LGFA. Interest rates ranged from 1.85 per cent to 2.25 per cent during the year and at 30th June 2019 Council held no term deposits.

A loan of \$12,659,646 was taken out with the LGFA in April 2019. The loan is repayable over a 15 year period at an interest rate of 3.80 per cent. As repayments are made at 6 month intervals the outstanding loan balance at 30 June 2019 was \$12,659,646.



Investment income generated from LGFA for the 2018/19 financial year totalled \$217,124 compared to a total of \$376,098 in 2017/18. In addition Council received \$68,854 in bonus interest for the 2017/18 financial year.

ANZ Bank

An amount of \$157,008 of council funds was held in an ANZ call account at the start of the year. Interest rates remained at 1.90 per cent until a decision was made to close this account in November 2018 and the proceeds were transferred to our Commonwealth Bank working account. Interest of \$1,114 was received during 2018/19 (\$3,030 in 2017/18).

Term Deposits

No other term deposits were held during the year.



The following factors were taken into account in managing Council's investments:

- Council's current investment policy
- The movements in official interest rates;
- Investments only being placed with institutions rated at least A-, except where funds are covered by a Commonwealth Government guarantee;
- Diversification of Council investments;
- The annual bonus received from the LGFA (\$68,854 in 2018/19) - the equivalent of 0.35 per cent if fully attributed to Council investments;
- Substantial support currently provided by the LGFA to the local government industry; and
- The LGFA being fully guaranteed by the South Australian Government.

11.6 Planning Reform Update - July 2019

Brief

This report presents an update on the status of the implementation of the *Planning, Development and Infrastructure Act 2016* as at 31 July 2019.

RECOMMENDATION

The Committee recommends to Council that the Planning Reform Implementation Update - July 2019 report be noted.

Introduction

Planning reform in South Australia is being introduced progressively via the *Planning, Development and Infrastructure Act 2016* and associated regulations. This report provides an update of the current activities associated with its implementation.

Discussion

Planning and Design Code

Consultation for Phase 1 of the Planning and Design Code - Out of Council Areas closed on 29 March 2019. While this was not directly relevant for the City of West Torrens, it did provide some insight into the structure of the Planning and Design Code. This phase of the Code became operational on 1 July 2019.

Initially Phase 2 of the Code - Regional Areas was due to be released for consultation in July 2019 with Phase 3 - Metropolitan Area due for release towards September 2019. This process has now fundamentally changed with consultation on Phases 2 and 3 to be combined with timing expected to be in October 2019. This has resulted in a reduction in consultation and opportunity to review the structure and policies contained in the Code and ultimately, one less opportunity to provide feedback on the proposed Code.

In order for Council to be able to provide comment on the key community issues in relation to the Planning and Design Code, the Administration will be proposing to seek community input on a range of key issues prior to the formal Code consultation process. These include heritage and character and urban infill. This should assist in formulating Council's response to the Planning and Design Code consultation in a timely manner given the large amount of information which will be released in a consolidated manner.

The City of West Torrens is only one of a handful of metropolitan councils invited to be a part of a DPTI project involving road testing draft infill policies. This has involved CWT providing real examples of development in the City to see how the new policies would affect the outcome and being part of an infill workshop to discuss the policies and outcomes.

Renewable Energy Discussion Paper

On 24 July 2019, the State Planning Commission released a Renewable Energy Discussion Paper which addresses proposed changes to renewable energy policy in the Planning and Design Code. The paper deals predominantly with large scale renewable energy facilities such as wind farms however, the Administration is currently reviewing the paper for any issues relevant to the City of West Torrens.

Heritage and Character

At its meeting on 2 July 2019, Council resolved not to undertake a Development Plan Amendment for Contributory Items and instead write to the minister supporting the findings of the PERDC and a statewide, considered and funded approach to addressing heritage and character in the new planning system. A letter was sent to the Minister on 10 July with no response received to date.

Performance Indicators (System) Scheme

Schedule 4 of the *Planning, Development and Infrastructure Act 2016* (the Act) allows the State Planning Commission (the Commission), with the approval of the Minister for Planning, to establish a scheme for the monitoring and evaluation of performance in the exercise of statutory functions under the Act.

The scheme may include –

- (a) the collection, retention, analysis and provision of information; and
- (b) the provision of returns, reports and information to the Commission; and
- (c) requirements as to the undertaking of audits and self-assessments, or requirements to arrange, or submit to, audits by persons who hold specified qualifications; and
- (d) the evaluation of performance and the preparation of reports by the Commission; and
- (e) other matters as the Commission thinks appropriate.

The Commission has prepared this Scheme in relation to part a, to effectively monitor, evaluate and report on the performance, efficiency and various quantitative aspects of the development assessment scheme (Part 7 of the Act).

It is expected that following the commencement of the new planning system, this scheme will be expanded to include a wider range of indicators relating to qualitative and cumulative outcomes of new development (to analyse matters such as built form, environmental, social and economic outcomes)

Planning Reform Steering Committee

The Administration has had a Planning Reform Steering Committee in place since the planning reform agenda was announced. The focus of this group has shifted over the past 12 months from preparing for the changes to the practical implementation of the new system. Four project teams have been established to consider the impacts in the following areas:

- Planning policy
- Assessment manager and accredited professionals
- e-Planning
- Communications Strategy

Planning policy

Review of the Development Plan is underway and administration continue to extract the local nuances of the West Torrens Development Plan to highlight to DPTI a desire for the retention of such policy within the Code.

Communications Strategy

The Communications Strategy development is well underway with identification of key stakeholder groups, timing of communications and communications methods. A project plan and timeline for key activities is currently being updated and will continue to evolve as more detail is known.

Conclusion

Landscape South Australia Bill 2019

Government Bill

The *Landscape South Australia Bill 2019* (Bill) is a Bill to repeal and replace the *Natural Resources Management Act 2004* (NRM Act). The Bill in essence aims to decentralise decision making relating to the environment, and recognise the impact of climate change and other factors not recognised in the NRM Act.

The Bill establishes a new framework for how the state's natural resources are managed, and intends to create a simpler and more accessible system.

The key elements of the reform are:

- Replacing regional natural resource management boards with new arms-length regional landscape boards and giving communities and landholders a greater voice in how natural resources are managed;
- A new Green Adelaide board focused on seven priorities that will help Adelaide become the most ecologically vibrant city in the world. These are:
 - Coastal management
 - Urban rivers and wetlands;
 - Water-sensitive urban design;
 - Green streets and flourishing parklands;
 - Fauna and flora in the urban environment;
 - Controlling pests, animals and plants; and
 - Nature education.
- A cap on increases to land and water levies to reduce cost of living pressures for all South Australians; and
- More action on ground, with a focus on partnerships, a simpler approach to planning and creating opportunities for natural resources management focused on programs and initiatives in regional communities.

Boards

Section 12 of the Bill provides that, "Green Adelaide" or the "Green Adelaide Board" (GAB) will be established as a landscape management region covering metropolitan Adelaide. The GAB will be able to raise levies to support residents to live more sustainably and invest in community development.

Section 13(5) of the Bill establishes the GAB to make Adelaide the "most ecologically vibrant city in the world".

The GAB will have between 6 and 10 members, all of whom will be appointed by the Minister. The only current guidelines for eligibility to sit on the GAB is under section 17 of the Bill which states that a person must be on the relevant Council electoral roll to be considered. There is no specific consideration allowing for elected members to sit on the GAB. Section 16 of the Bill directs the selection criteria to be more focused on environmental expertise vs representatives (i.e. Elected Members).

Section 67 of the Bill outlines that land levies will be collected in the same manner as the NRM levies, by Councils. These levies will be to reimburse Council for their contributions to the scheme. It will be known as the **regional landscape levy**.

The Bill has passed the House of Assembly and is now in committee in the Legislative Council.

Local Government (Rate Oversight) Amendment Bill 2018**Government Bill**

The Bill seeks to amend the *Local Government Act 1999* to introduce rate capping in South Australia and had its first reading in June 2018.

The Bill also provides that the Essential Services Commission of South Australia (ESCOSA) will be responsible for making rate cap determinations, assessing applications from councils for variations to the rate cap and reporting on the outcomes of the system. ESCOSA may charge councils a fee for assessing a variation application and applications will need to be lodged by 31 March for the following financial year.

ESCOSA will determine the basis of the rate cap, e.g. whether it will relate to a price or particular index (CPI, LGPI etc.) and whether the cap will include any efficiency or productivity component.

The details of how the rate cap will be determined will be subject to ESCOSA guidelines that are yet to be developed.

It intends that the cap be applied to a 'base standard rate', which is a nominal rate that is arrived at by dividing the total annualised general rate revenue for a council area by the number of rateable properties in that area at the end of a base year (30 June). This model accounts for growth in the number of rateable properties over the course of a year.

A council may apply to ESCOSA for a variation from the rate cap for a maximum period of up to 5 years. In applying for a variation, councils will need to provide the reasons for the variation application, evidence of community consultation and an assessment of the likely impact on ratepayers. Councils will be expected to make efficiencies across their operations before applying for a rate cap variation and will need to demonstrate they have considered funding priorities and alternative sources of revenue.

Consistency with long term financial plans and infrastructure and asset management plans will be a critical component of an application for a variation.

Separate rates and service rates and charges are excluded from the rate cap calculation, but a council must inform ESCOSA if they proposed to introduce a separate rate or service rate or charge as this will be taken into consideration when they set the primary rate cap for that council.

ESCOSA will be required to monitor and review each council's compliance with the system and prepare reports on the effects of rate capping on councils and any trends that may arise as a result of the rate capping scheme.

The Minister may take action in relation to a council under Section 273 on the basis of a report by ESCOSA. Currently this provision includes ICAC, the Auditor-General and/or the Ombudsman.

The Bill passed the House of Assembly on 24 July 2018, and was received in the Legislative Council on 25 July 2018. It was adjourned at its second reading on 26 July 2018.

The Bill was moved at second reading by the Hon D W Ridgway, and debated on 6 September 2018 by the Hon I Pnevmatikos.

The Bill has been Negatived in the Legislative Council.

Planning, Development and Infrastructure (Code Amendments) Amendment Bill 2019 **Private Members Bill**

This Bill was introduced to the Legislative Council on 27 February 2019. The Bill affects the heritage places provisions of the PDI Act and intends to remove the requirement for 51% of relevant owners to approve of a property or area being designated as a heritage character for preservation zone or subzone.

The Bill has been received in the House of Assembly on 4 July 2019, and has been adjourned at first reading.

Independent Commissioner Against Corruption (Investigation Powers) No 2 Amendment Bill 2018

Government Bill

This is a Bill to amend the *Independent Commissioner Against Corruption Act 2012* (Act). It is the second Bill introduced in this parliamentary session which intends to amend the Act.

The Bill seeks to amend the functions of the Independent Commissioner Against Corruption (ICAC) with broad sweeping reforms, including allowing the Commissioner to conduct a public inquiry, investigators being able to arrest individuals without warrants in certain circumstances and other broad changes.

The Bill was introduced to the Legislative Council, read a first time, and adjourned at second reading on 15 November 2018. The Bill passed the Legislative Council with amendments on 21 March 2019 and has been adjourned at second reading in the House of Assembly on 19 June 2019.

Labour Hire Licensing Repeal Bill 2018

Government Bill

This is a Bill to repeal the *Labour Hire Licensing Act 2017*.

It was introduced and read on 28 November 2018. It was debated frequently throughout February, and referred to Committee on 14 February 2019. A third reading was called on 27 February 2019, and was adjourned in the Legislative Council on 28 February 2019. The Bill was debated further in the Legislative Council on 16 May 2019, and has again been adjourned.

Development (Site Contamination) Variation Regulations 2018**Government Regulations**

The Department of Planning, Transport and Infrastructure (DPTI) has released the draft *Development (Site Contamination) Variation Regulations 2018*, along with an explanatory statement. These draft regulations are designed to ensure site contamination is considered in an appropriate way, commensurate with the nature of the development, the potential risk and stage in the planning process. They also aim to facilitate timely and appropriate consideration of contamination issues and will encourage clarity of evaluation by planning authorities.

Planning authorities, developers and other stakeholders have an important role in managing site contamination by ensuring good planning and development doesn't exacerbate risk.

Stakeholders are encouraged to make submissions relating to the draft regulations to the Environmental Protection Agency and/or DPTI prior to noon on 15 May 2019. No feedback on the on the draft has yet been released by DPTI.

Valuation of Land (Separate Valuations) Amendment Bill 2018**Government Bill**

This Bill was introduced to the Legislative Council and proposes amendments to clarify that separate assessments should only be made in circumstances where it is required by law or when a property has been separately occupied since 1967 or under a shack site lease and is situated on land where formal subdivision is prohibited.

The Bill was introduced to the Legislative Council and read a first time on 17 October 2018. It has been adjourned at second reading.

Local Government (Fixed Charges) Amendment Bill 2018**Government Bill**

This Bill seeks to amend s152 of the Local Government Act 1999.

The amendment seeks to include each residence in a retirement village (within the meaning of the *Retirement Villages Act 1987*) as a type of allotment to which a fixed charge for rates cannot be applied.

The Bill was introduced to the Legislative Council and read a first time on 17 October 2018. It has been adjourned at second reading.

Single Use and Other Plastics (Waste Avoidance) Bill 2018**Private Members Bill**

This Bill seeks to regulate the sale and supply of single use and other plastics.

The Bill provides that retailers must provide alternatives to prohibited plastics before 1 July 2023 and creates an offence for releasing helium-filled balloons into the open. It also creates a requirement to provide disposal instructions for fishing tackle and personal hygiene products.

The Bill was introduced to the Legislative Council and read a first time on 25 July 2018. The Bill has been adjourned at second reading.

Freedom of Information (Miscellaneous) Amendment Bill 2018**Private Members Bill**

This Bill seeks to change the definition of Public Interest, amend the processes for determining that a document does not exist and changes definitions relating to the nature and scope of an application. It also changes the processes for determination of an application.

The Bill passed the Legislative Council with amendments on 18 October 2018. It was adjourned a second time in the House of Assembly on 7 November 2018.

Select Committee on Moratorium on the Cultivation of Genetically Modified Crops in South Australia

A Select Committee of the Legislative Council has been established to inquire into and report on the moratorium on the cultivation of Genetically Modified (GM) crops in South Australia, with specific reference to -

- (a) The benefits and costs of South Australia being GM-free for the state, its industries and people;
- (b) The effect of the moratorium on marketing South Australian products both nationally and internationally including:
 - i. Costs and benefits to South Australian industries and markets of remaining GM-free;
 - ii. Costs and benefits to South Australian industries and markets from lifting the moratorium on cultivating GM crops in South Australia;
 - iii. Current or potential reputational impacts, both positive and negative, on other South Australian food and wine producers, that may result from retaining or lifting the moratorium;
 - iv. Consideration of global trends and consumer demands for GM crops/foods versus non GM-crops/foods;
- (c) The difference between GM and non-GM crops in relation to yield, chemical use and other agricultural and environmental factors;
- (d) Any long term environmental effects of growing GM crops including soil health;
- (e) The potential for contamination of non-GM or organic crops by GM crops, including:
 - i. Consideration of matters relating to the segregation of GM and non GM crops in the paddock, in storage and during transportation;
 - ii. The potential impacts of crop contamination on non-GM and organic farmers;
 - iii. Consideration of GM contamination cases interstate and internationally; and
- (f) Any other matters that the Committee considers relevant.

The Committee met on 12 December 2018, and the matter is ongoing.

Overabundant and Pest Species Inquiry

The Natural Resources Committee resolved to inquire into the management of overabundant and pest species in South Australia with particular reference to:

1. Efficacy of existing or novel regulatory, policy and partnering frameworks used to manage overabundant and pest species
2. Costs of managing overabundant and pest species
3. Impacts of overabundant and pest species on agricultural outputs, environmental values, tourism, road safety, and amenity
4. Any other related matters.
