8 REPORTS OF THE CHIEF EXECUTIVE OFFICER

8.1 Possible Dog Park - River Torrens Linear Park Torrensville

Brief

This report advises Committee Members that the Administration has been progressing matters regarding the potential use of a portion of River Torrens Linear Park land at Torrensville for a dog park, following Council's resolution of 7 August 2018.

RECOMMENDATION(S)

The Committee recommends to Council that:

- 1. The report be noted.
- 2. The Administration be authorised to enter into negotiations with representatives from the Department for Environment and Water (DEW) in an endeavour to secure a lease or licence for land within the River Torrens Linear Park Reserve for use as a dog park.
- 3. A further report be provided to the Committee following negotiations with the Departmental representatives.

Introduction

At its meeting of 7 August 2018, a Motion with Notice seeking investigations into the possible use of land within the River Torrens Linear Park Reserve for a dog park was put to Council and the Council subsequently resolved:

That the Administration prepare a report that looks at obtaining a section of unused and unkempt Linear Park that is under the control of the water Minister at the end of Hayward Avenue and West Street Torrensville, for the purpose of setting up a dog park for small and large dogs in line with the concept used at Pooch Park at Rowells Road Locklevs.

Discussion

The location of the land in question is identified in the attached aerial plan (Attachment 1).

Subsequent to the above resolution, the Administration has determined that separate, segregated areas, either side of the shared use path are likely to be required to cater for small and large dogs. The approximate combined area of the proposed two segregated areas is 3,500m².

The Administration has been endeavouring to progress the matter with who it believed to be the relevant party i.e. representatives from SA Water (albeit with some frustration). Subsequently, assistance has been sought from the Hon Dennis Hood MLC, who forwarded information through to the Hon David Speirs MP (Minister for Environment and Water), in an endeavour to determine whether the controlling authority has any appetite to consider Council's request for, and proposed use of, the land.

Following the receipt of an encouraging response from the Minister for Environment and Water (Attachment 2) the Administration has been in contact with representatives from his Department to seek an understanding of likely terms and conditions and approximate lease or licence fees. At the date of preparation of this report a response had not been received from the Department in regard to these queries. Should a response be provided prior to the Committee's meeting, a verbal update will be provided by the Administration at the meeting.

At this time, the Administration is seeking the Committee's/Council approval to enter into formal negotiations with the Department to seek the grant of lease or licence.

The Administration further acknowledges that:

- There is no existing funding within Council's budget to expend monies on necessary infrastructure e.g. perimeter fencing and other associated infrastructure; and this project will be referred to the 2022/2023 budget deliberations; and
- A further report will need to be provided to the Committee following negotiations with the Department.

There are no perceived climate impact considerations in regard to this matter.


Conclusion

8.2 Request for Extension of Trading Hours - Weigall Oval Clubroom Building

Brief

This report advises Committee Members that correspondence has been received from the presidents of the Adelaide Angels Baseball Club and Adelaide Omonia Cobras Soccer Club seeking a variation (extension) of the trading hours for the recently completed Weigall Oval shared clubroom building.

RECOMMENDATION

The Committee recommends to Council that it provide its consent in its capacity as landlord for an extension of the trading hours for the new Clubroom function space, tenanted by Adelaide Angels Baseball Club and Adelaide Omonia Cobras Soccer Club, from 11pm to 1am on Friday and Saturday nights, and also to 1am on Sunday nights when the following Monday is a gazetted public holiday, subject to any necessary development consents and/or other relevant approvals being sought and obtained.

Introduction

At its meeting of 22 September 2020 the City Facilities and Waste Recovery General Committee considered a report which sought an extension of the trading hours for the bars and function space within the newly redeveloped Weigall Oval shared clubroom building (from the closure time of 11pm stipulated within the development approval conditions until 12 midnight on Saturdays and Sundays).

A development application to vary the hours was subsequently lodged and information was provided to the Community in accordance with the Category 3 - Development Application consultation process.

Unfortunately, there was some inconsistency between the advice which was provided to the Committee meeting and that which was included within the public consultation material/advice. In addition, there were a number of negative objections/representations received as a result of the Category 3 consultation. Given these matters, and subsequent to consultation with the Club presidents, it was determined that the best course of action at that time was to withdraw the existing application and not proceed any further with it until expiry of the current licence terms i.e. 30 September 2021 (which would permit the community to gain an understanding and appreciation of the Clubs' operations in the new facility).

At its meeting of 28 September 2021 the City Facilities and Waste Recovery General Committee received advice that the Adelaide Angels Baseball Club (Angels) had written to Council seeking an extension of their liquor licence hours on Friday and Saturday nights (and on Sunday nights when the following Monday is a public holiday) (Attachment 1).

At the time of preparation of the report, the Administration was awaiting correspondence from the other tenant within the building, the Adelaide Omonia Cobras Soccer Club (Cobras).

Discussion

The outstanding correspondence from the Cobras has now been received and is attached for Committee Members' information (Attachment 2).

As is indicated above, the current development approval for the premises permits the clubs to operate the bar, dining and function areas within the building between the hours of 7.30am and 11pm on any day.

Information contained within the Clubs' submissions specifies that:

- They seek that the trading time be extended until 1am on Friday and Saturday nights, and also to 1am on Sunday nights when the following Monday is a gazetted public holiday; and
- Trading was permitted until 12 midnight under the development approval which operated for the previous facility.

The Administration notes that the variation in hours sought has now been extended from that which was previously requested last year i.e. from 11pm to 12 midnight, to now be from 11pm to 1am on Friday and Saturday nights (and Sunday nights when the following Monday is a public holiday).

The Clubs have suggested that one reason for the additional hour sought has arisen following the non-continuance of a number of booking enquiries subsequent to enquirers being advised that activity within the function space needed to cease by 11pm. Both Clubs have also advised that it is not their intention to utilise the 1am closure time on a regular basis (albeit the Administration acknowledges that this intention may change over time should the hours be varied in accordance with their requests).

The Administration is not aware of any complaints having been received in regard to the operation of the function space following completion of the redeveloped facility since its opening approximately 12 months ago and is accordingly supportive of the Clubs' requests (and on this basis has proactively lodged a development application seeking the extension of trading hours).

Should Members agree to the Clubs' request it is anticipated that a public consultation process would occur seeking comment and/or submissions from nearby residents in accordance with standard development approval protocols regarding requests of this nature.

Climate Impact Considerations

(Assessment of likely positive or negative implications of this decision will assist Council and the West Torrens Community to build resilience and adapt to the challenges created by a changing climate.)

There are no significant climate change impacts envisaged as a result of consideration of this matter

Conclusion

The presidents of the Adelaide Angels Baseball Club and Adelaide Omonia Cobras Soccer Club have written to Council seeking a variation (extension) of the trading hours for the Weigall Oval shared clubroom building. The Administration is supportive of the Clubs' request subject to any necessary development consents and/or other relevant approvals being sought and obtained.

RE: Application to vary the hours of operation at Weigall Oval (to extend the closure to 1am on Friday and Saturday nights)

Thank-you for your time and the opportunity to discuss the operating hours at Weigall Oval.

After a successful transition in to Weigall Oval since it's opening in December 2020, the Adelaide Baseball Club (ABC) would like to ask for your support in applying for the operating hours on both Friday and Saturday nights (and Sunday when Monday is a gazetted SA public holiday) to be extended from 11pm to 1am

We would like to make the following points in consideration of this application;

- a) It is Adelaide Baseball Club's intention to only use this extended timeline on occasions where specific functions require.
- b) The previous club facility, prior to the redevelopment, had the capacity to operate until 12 midnight. The ABC is unaware of any direct issues with its historical operations when this was in place.
- c) The more centralised location of the new facility should materially mitigate noise levels in comparison to the previous facility location.
- d) The ABC fully supports the City of West Torrens' commitment to utilising the development as a broader community access facility. The scope of utility for the local community is mutually enhanced by allowing an operating window to 1am on Friday and Saturday nights as many booking enquiries to date, have been negated due to the current curfew.

As a member of the local community and a direct neighbour to many, the entire leadership team and members of the Adelaide Baseball Club acknowledge the opportunity and obligations being provided with the Weigall Oval redevelopment by the City of West Torrens.

Adelaide Baseball Club (ABC) is committed to continuing its very proud 113 year history as an integral part of our local community. Operating the new club room facility in a responsible, integrated manner is a foundational underpinning of this endeavour.

Accordingly, we acknowledge that CAP have a responsibility to consider the surrounding residents and similarly we also urge them to consider the optimal utilisation of the facility by the community in their deliberation on this matter.

Dear Mr Ottanelli,

I am writing on behalf of our club, the Adelaide Omonia Cobras FC, to respectfully ask for your support in amending the operating hours of the new Weigall Oval reserve from 11pm to 1am on Fridays, Saturdays, and Sundays where a public holiday follows.

Together with our joint tenants, the Adelaide Angels Baseball Club, we are hoping the Council Assessment Panel will give special consideration to our request, paving the way to fully utilise the use of the function room- not just for our clubs, but also for our community with events and activities for people of all ages and interests.

Evidence shows that more diverse options lead to a more connected and resilient community, help create a more inclusive social life, and improve safety and reduce crime.

Prior to the redevelopment of Weigall Oval, the operating hours of the old facility catered for use until midnight. It was only on selected occasions that we made use of the extended operating hours and did so in a respectful manner in terms of keeping noise to a minimum level and quietly leaving the car park. The club is unaware of any issues raised by surrounding residents during any times of extended operation.

The Adelaide Omonia Cobras FC are celebrating our 50-year anniversary next year and look forward to showcasing our brand-new function rooms during these celebrations together with the support of the City of West Torrens and our community. We would love the opportunity to host some of our celebratory events with an extended time.

We would like to be clear that our intention is to *only* use this extended time on occasions where specific functions may occur, and it would certainly not be on a weekly basis.

Our goal is to provide well utilised and inclusive facilities, balancing all the factors.

The interests of everyone – local community, our increasing resident population, and our highly expectant visitors – are being considered. Public safety is of course paramount.

I would welcome the opportunity to meet with you or members of the CAP, to put our case forward in more detail and find a positive outcome for everyone involved.

8.3 High Impact Acid Solutions Pty Ltd - Request for Extended Term

Brief

This report advises Committee Members that High Impact Acid Solutions Pty Ltd, the lessee of the building at the rear (northern extent) of the Council depot has written to Council seeking to activate the renewal provided within its existing lease agreement.

RECOMMENDATION(S)

The Committee recommends to Council that:

- 1. High Impact Acid Solutions Pty Ltd be advised that Council provides its consent, in its capacity of Underlessor, for the renewal/extended term (of a further 3 years from 1 February 2022 until 31 January 2025) for High Impact Acid Solutions' use of the freestanding building at the rear of the Council depot located at 240 Morphett Road, North Plympton. Further, a valuer be engaged to determine the market rental value of the tenancy at the date of commencement of the renewal term in accordance with the terms of the lease.
- 2. Should Council provide its consent for the Extension, a Deed of Extension be prepared by Council's solicitors.
- 3. The Mayor and Chief Executive Officer be authorised to sign and/or seal any documentation to give effect to this resolution.

Introduction

High Impact Acid Solutions Pty Ltd (High Impact) holds a 3+3 year underlease over the freestanding building (described as Tenancy 7) at the rear of the Council Depot at 240 Morphett Road, North Plympton. Its lease of the premises commenced on 1 February 2019 and the current term expires on 31 January 2022. Current rent paid by High Impact is \$44,315.88 per annum plus GST and outgoings. Under the terms of the lease the rental is increased by CPI (Adelaide All Groups) on each anniversary of the lease commencement during the term, and is to be reviewed to market at the commencement of the renewal term (if the renewal is activated by the lessee).

Discussion

The underlease agreement requires High Impact to write to Council no earlier than 9 months and no later than 6 months prior to expiry of the current (initial) term, requesting the Council to grant the renewal (of a further 3 years) provided within the underlease. Members will note that the attached request conforms to this requirement (Attachment 1).

On the basis that there have been no breaches of the lease during the initial term, the Administration recommends that the renewal for a further 3 years, i.e. from 1 February 2022 until 31 January 2025, be granted. Should the Committee (and subsequently Council) proceed in accordance with this recommendation, the Administration will instruct its valuer/property consultant to undertake the necessary market rental valuation of the premises to determine the rental at the commencement of the renewal term.

Climate Impact Considerations

(Assessment of likely positive or negative implications of this decision will assist Council and the West Torrens Community to build resilience and adapt to the challenges created by a changing climate.)

There are no foreseen or anticipated climate impacts arising as a result of consideration of this matter.

Conclusion

High Impact Acid Solutions Pty Ltd has written to Council seeking to activate the renewal/extended term (of a further three years from 1 February 2022) provided within its existing agreement. On the basis that there have been and are no current breaches, and given that the lessee has complied with its obligations in seeking the renewal, the Administration suggests that the Committee recommend to Council that it provide its consent to the request.

8.4 Request to purchase portion of Kevin Avenue Reserve, West Beach

Brief

A request, seeking to purchase a portion of Kevin Avenue Reserve, West Beach, has been received from the resident whose property adjoins the western side of the Reserve.

RECOMMENDATION

The Committee recommends to Council that the resident be advised that, following its consideration of the request, Council is not willing to dispose of any portion of the Kevin Avenue Reserve.

Introduction

Ms Kelly Naughton, the owner of property at 67 Northern Avenue, West Beach, which lies immediately east of Kevin Avenue Reserve, has written to Council seeking to purchase a 5 metre strip of land on portion of the north-western extent of the Reserve to allow for redevelopment of the resident's property (Attachment 1).

Discussion

Initially, the Administration wishes to advise that the land in question is classified as Community Land.

Given this classification, there are a number of steps that would need to occur should Council determine to proceed with a potential sale to the resident.

In summary:

- The Local Government Act 1999 prescribes that the Council cannot sell the land without the Community Land classification being revoked.
- The first step in the revocation process is for the Council to consider the resident's request (i.e. this meeting) and determine whether it wishes to make a resolution to proceed with revocation of the Community Land classification, (if not, that would end the process).
- Should Council determine that it wishes to proceed, the Act requires that a public consultation process occur (for a period of a minimum of 21 days) that process would invite comments and submissions from the community in regard to the proposal. At this time the Council would likely seek a market valuation of the land. (Note In circumstances such as this the valuer would be instructed to undertake the valuation using a "before and after" approach which would be cognisant of the value that the additional land would add to the consolidated property).
- Following the public consultation process the Council would need to give due consideration to any comments or submissions that are received (again at a formal meeting) regarding the proposal and determine whether it still wishes to proceed with the revocation (if not, that would end the process).
- If the Council determines to proceed, it needs to provide a submission to, and seek the approval of, the relevant State Government Minister for the Community Land classification to be revoked.
- The Minister will consider the information that has been provided by the Council and make a
 determination to either revoke or not revoke the Community Land classification and
 subsequently advise the Council of his/her decision (if the Minister does not agree to revoke
 the classification the process will end).

• If the Minister determines to revoke the Community Land classification the Council then needs to consider a further report (at a formal meeting) and confirm whether or not it wishes to accept/confirm the revocation. Should the Council confirm the revocation a notice needs to be placed in the Government Gazette and, subsequent to this, a contract would be drawn up for sale of the land (and consolidation with the resident's Certificate of Title/allotment.)

Whilst the above is provided for information purposes, the Administration does not support the resident's request, principally on the following grounds:

- Reduction in the area of the Reserve of some 130m² or thereabouts (from approximately 1,800m² to 1,670m² i.e. approximately 7 per cent) would be to the detriment of the local and wider community and the sole benefit of the resident (albeit, as previously indicated, the valuation would take account of the development potential which is inherent within/provided by the additional land);
- Excision of the nominated portion of the Reserve would result in the creation of an irregular boundary on the northern extent of the Reserve; and
- Whilst the strip of land sought by the resident is ostensibly currently used as garden bed it
 does contain a/some mature tree(s) which would likely require removal and provides a buffer
 and additional opportunities for children's play.

The Administration also sought the opinion of Ward Councillors in regard to the request and the response received essentially mirrored the sentiments of the Administration above, albeit with the addition of a further factor i.e. "with the new planning laws, blocks are getting smaller, so community shared space will be more important than ever".

Climate Impact Considerations

(Assessment of likely positive or negative implications of this decision will assist Council and the West Torrens Community to build resilience and adapt to the challenges created by a changing climate.)

Climate impacts may arise should the Council provide its consent for the matter to proceed and if the resident subsequently receives approval to progress with development of the property.

Conclusion

A request has been received from a resident whose property adjoins portion of the northern boundary of Kevin Avenue Reserve, West Beach seeking to purchase a 5 metre strip of the Reserve. The Administration does not support the resident's request.

I've been passed along your details from Steven Burke in planning after talking to him on Friday regarding our property at 67 Northern Ave, West Beach.


We are interested in purchasing some of the council land next door to us.

8.5 H C Khor & Ors (Superlot 4) Request for grant of new Authorisation and Permit - portion of Reid Street. Thebarton

Brief

This report advises Committee Members that, following contact from the Administration, the agent acting on behalf of H C Khor and Others has advised that its client wishes to seek a new permit for a term of 3 years (from 30 November 2021 until 29 November 2024) for its use of a portion of Reid Street, Thebarton.

RECOMMENDATION(S)

The Committee recommends to Council that:

- H C Khor & Ors be granted an Authorisation and Permit for a term of 3 years
 (from 30 November 2021 until 29 November 2024) for its use of a portion of Reid Street,
 Thebarton at a commencing permit fee of \$1,350pa plus GST. The permit fee to increase by
 Adelaide All Groups CPI (or similar index should that index cease to exist) on each
 anniversary of the commencing date during the term.
- 2. The Mayor and Chief Executive Officer be authorised to sign and/or seal the Authorisation and Permit or similar agreement to give effect to the resolution.

Introduction

At its meeting of 4 September 2018 the Urban Services Committee of Council considered a report seeking the grant of an Authorisation and Permit utilising a reduced permit area for a term of 5 years to the current permit holder, having previously provided its consent for the former permit holder (the University of Adelaide) to surrender its permit, conditional upon the grant of the new permit at its meeting of 15 November 2016.

Following its consideration of the matter the Committee recommended to Council (and the Council agreed) that the Authorisation and Permit be granted for a term of 5 years from 30 November 2016 at an initial fee of \$1,200pa plus GST (the Authorisation is required as the applicant/permit holder has alterations on or under the road).

Discussion

Members are likely to be aware that the *Local Government Act 1999* (as amended) restricts the term of a permit for use of (portion of) the road which may be sought by an applicant to a maximum of 5 years.

Given the forthcoming expiry date, the Administration contacted the permit holder to determine whether a further permit term is sought. Following discussions, the agent acting on behalf of the permit holder applicant has indicated that the applicant seeks a permit for a further 3 years (i.e. from 30 November 2021 until 29 November 2024).

The portions of the road sought within the new Authorisation and Permit agreement do not differ from those contained within the current agreement and are identified within **Attachment 1**. The nominated areas comprise encroachments over the road (verandas etc.) and an underground neutralising pit.

Members should also note that the obligations on the permit holder contained with the existing/prior agreement to maintain the road and structures erected/installed within the permit area(s) and to remove them (including the underground infrastructure contained within the road) and make good on the expiry or sooner, have been retained in the new permit agreement.

There are no known climate change implications foreseen to arise as a result of the consideration or implementation of this matter.

Conclusion

The existing Authorisation and Permit held by H C Khor & Ors for use of portion of the northern side of Reid Street Thebarton expires on 29 November 2021. Following discussion with the permit holder a new permit for a further term of 3 years is sought and supported by the Administration.

8.6 Richmond Oval Staged Upgrade - Update

Brief

This report provides Committee Members with a status update in regard to the staged upgrade of Richmond Oval.

RECOMMENDATION

The Committee recommends to Council that the report be noted.

Introduction

At its meeting of 8 December 2020, Council allocated \$1,800,000 of the 2021 Local Roads and Community Infrastructure (LRCI) Program funds towards first stage of an upgrade to Richmond Oval. Members were advised that the first stage aimed to deliver additional sporting and recreational opportunities allowing for greater public access to the open space.

At the City Facilities and Waste Recovery Committee meeting held 23 March 2021, members were further advised that the Administration had developed the previous AFL (football) focussed Venue Improvement Plan for Richmond Oval and produced a preliminary high level concept plan to guide the staged upgrade and to incorporate additional sports and recreational activities on the site.

The original Venue Improvement Plan was developed to address the challenges associated with existing player change rooms and umpire rooms that are not suitable for female players and officials, match day coaches areas that do not meet contemporary expectations and public spaces that are not welcoming nor do they encourage community usage and benefit beyond football.

Further, at the City Facilities and Waste Recovery Committee Meeting held 27 July 2021, the committee was informed that a period of community consultation had commenced relating to the Stage One upgrade. A Community Day was held on 22 May 2021 at Premiership Park, with the majority of comments received supporting the proposal for the first stage of work. Simultaneously, the 'Your Say' platform was used to gather feedback regarding the proposed upgrade. 96.9 per cent of respondents to the online survey supported or somewhat supported the concept plan.

Comments were also provided by the West Adelaide Football Club, South Australian National Football League and Snooker SA.

Further funding of \$1 Million was approved for Richmond Oval by Council for the 2021/2022 financial year.

Additional consultation will be scheduled late in 2021 regarding future stages of the masterplan.

Discussion

A condition of the funding agreement (through the Local Roads Community Infrastructure - LRCI - Program) originally stipulated that all construction work must be completed by the end of December 2021. Due to COVID-19 restrictions faced across the nation, a blanket extension was granted to all councils (across Australia) until 30 June 2022.

Detailed design of the proposed elements of Stage One was completed in September and the package of works was put out to market. Tenders closed in early November and a small number submissions were received. Detailed analysis of the tenders has commenced and it is expected that a contract will be awarded within the next four weeks. In order to minimise the impact on the football season, it is expected that works will commence early in the New Year and be completed by April 2022.

Public consultation on the future stages of the masterplan as well as the priorities for the staged upgrade is about to commence. A face-to-face community consultation day has been scheduled for **Saturday 27 November 2021 from 9.30am until 11am** at Premiership Park. This date coincides with a combined 'one-club' training day scheduled for the WAFC men's and women's teams. A further survey will also be available on Council's *'Your Say'* platform following the consultation day.

Stakeholders including SANFL, Cowandilla Primary School, Richmond Primary School and local businesses will have the opportunity to provide feedback. Targeted consultation meetings will be held with the West Adelaide Football Club (WAFC) Committee, as well as existing tenants of the WAFC Facility, namely Snooker SA and SEDA College. Their input will be valuable in the design of the proposed grandstand including change rooms, public facilities and amenities as well as staging of the next works.

Climate Impact Considerations

(Assessment of likely positive or negative implications of this decision will assist Council and the West Torrens Community to build resilience and adapt to the challenges created by a changing climate.)

The implementation of the first stage of works at Richmond Oval will have a positive impact on the environment through an improved amenity of the space and reduced heat from additional green areas. Good quality green open spaces such as a redeveloped Richmond Oval will also contribute significantly to individuals including opportunities for social interaction; reduced stress levels; and opportunities to be more physically active.

Conclusion

The first stage of works is currently being procured and on-site works are expected to commence early in the New Year. Elements funded through the LRCI program are required to be completed by the end of June 2022.

The next phase of consultation will commence with a community day to be held on Saturday 27 November 2021 from 9.30am until 11am. This consultation will guide the next stages of the proposed upgrade.

8.7 Mellor Park - Update

Brief

This report provides Committee Members with a status update in regard to the upgrade at Mellor Park.

RECOMMENDATION

The Committee recommends to Council that the report be noted.

Introduction

At its meeting of 27 July 2021, the City Facilities and Waste Recovery General Committee was advised that the Administration will submit an application for the allocation of Commonwealth Local Roads and Community Infrastructure (Phase 3) funding to use for the refurbishment of the community hall, former Child and Family Health Service building and new Memorial on site. This funding will be available from early 2022.

At its meeting of 28 September 2021, the City Facilities and Waste Recovery General Committee received an update report, providing the following information:

- The landscape works at Mellor Park have nearly been completed.
- Key landscape works included:
 - Car parking;
 - Public tennis and basketball area;
 - Barbecue area with lighting;
 - Shelters and park furniture;
 - Irrigation, plants and turf installation; and
 - o New paths including to the former Senior Citizens Community Building.
- A delay occurred with the construction of the play space due to the time required to procure and supply the materials and equipment following nationwide restrictions.
- A new bocce court is being constructed at the northern edge of the site.
- A draft concept for the Soldiers Memorial, recognising the contribution and service of the (former) Lockleys RSL Sub-branch and local veterans, was presented.
- The former Senior Citizens community hall and the former Child and Family Health Service building will receive a general refurbishment and modernisation of the facilities.
- The installation of the movie wall posters ('Mellor Park Nostalgia Walk') is still to be completed.

Discussion

The landscape works have been completed and the site fence has remained in order to allow adequate time for the turf to become firmly rooted before accessed by the public. The construction of the playspace and installation of play equipment has commenced and is expected to be completed by early December 2021. The construction of the bocce court has also commenced and will be completed at the same time. Following the completion of this area, the site fencing will be removed and the public will have access to the entire site.

The Soldier's Memorial concept design has been presented to the State RSL and (former) Lockleys RSL Sub-branch members for feedback. A meeting has been scheduled to discuss the design, after which, a final design will be confirmed. It is expected that the on-ground works for this component of the Mellor Park Upgrade will commence in early 2022.

The Administration is also currently making the arrangements for the installation of movie posters into the reserve. This work will also commence early in 2022.

The upgrades to the former Senior Citizens community hall and the former Child and Family Health Service (CAFHS) building will also commence in early 2022. The upgrades will feature renewal of internal facilities and the inclusion of an accessible toilet within the Lockleys Community Building; to encourage community use, programs and hire. A kitchenette will also be included within the former CAFHS building to allow for hire for birthday parties and other small events/activities.

Climate Impact Considerations

(Assessment of likely positive or negative implications of this decision will assist Council and the West Torrens Community to build resilience and adapt to the challenges created by a changing climate.)

This project contributes to the climate change resilience of the local area.

Conclusion

Landscape works have been completed at Mellor Park and the works are underway for the playspace and bocce court. The site is scheduled to be open to the public from early December.

Work on the new Soldiers Memorial will commence early next year along with the minor refurbishment of the Community Hall and former Child and Family Health Service building.

8.8 Camden Oval - Update

Brief

This report provides Committee Members with a status update in regard to the upgrades at Camden Oval.

RECOMMENDATION

The Committee recommends to Council that the report be noted.

Introduction

At the City Facilities and Waste Recovery Committee meetings held 3 August 2021 and 28 September 2021, members were advised that:

- A grant application submitted through the Office for Recreation, Sport and Racing Infrastructure fund for \$300,000 had been successful. Matching Council funding of \$300,000 is a requirement of the grant agreement.
- The grant funding is to be used for the construction of four netball courts with lighting, toilet facilities and club shelter at Camden Oval.
- The new netball courts would be constructed over the existing three tennis courts and expand further into the reserve to allow for the additional court.
- The Plympton High School Old Scholars (PHOS) Camden Netball Club will relocate to Camden Oval at the completion of the project. The Club currently hold a licence agreement over three courts at Golflands Reserve, Glenelg North which do not meet competition standards.
- The Netball Club will have access to the larger PHOS Camden Sports and Social Club (PCSASC) facility during and after their games and training times, should the netball club desire access.

Discussion

Work on the construction of the new courts commenced in September 2021 and the asphalt surface is now complete. Fencing work commenced mid-November and the installation of the lighting towers will follow in early in 2022. The netball courts sporting (and coloured) surface will be laid early in 2022, after which, the courts will be available for use.

Subsequent to the completion of the courts and lighting elements, work will commence on the shelter/storage facility (likely February 2022). The new facility will offer Club storage, an open clubroom area, two accessible toilets and a small canteen space (Site Plan - Attachment 1). This will allow players and parents to have accessible facilities in close proximity to the courts.

Landscaping works across Camden Oval will be the final component of the original masterplan for the site. Irrigation and turf will be laid in the north-western area around the netball courts as well as the southern edge, adjacent the new cricket nets. It is expected the work will be complete before June 2022.

Climate Impact Considerations

(Assessment of likely positive or negative implications of this decision will assist Council and the West Torrens Community to build resilience and adapt to the challenges created by a changing climate.)

There are no known climate change impacts arising as a result of the consideration of this matter.

Conclusion


Following the successful application for funding for netball infrastructure at Camden Oval, works have commenced on constructing four new netball courts with lighting. Early in 2022, a storage facility and shelter will be constructed, and a licence will be held by the PHOS Camden Netball Club (relocating from Golflands Reserve).

Final landscaping elements across the site will be the final component of the Camden Oval masterplan and will commence in the second quarter of 2022.

8.9 Apex Park - Update

Brief

This report provides Committee Members with a status update in regard to the upgrade at Apex Park, West Beach.

RECOMMENDATION

The Committee recommends to Council that the report be noted.

Introduction

The City Facilities and Waste Recovery General Committee has previously been advised that:

- \$1 Million of funding was secured through the State Government 'Open Spaces' fund to support the next stage of works at Apex Park (northern part of the site) with Council required to contribute matching funding. The next stage includes:
 - o Removal of dense vegetation (weed species) along northern edge of site;
 - Shaping and new planting of wetland (northern edge);
 - A new nature playspace on northern bank of wetland;
 - Construction of a BMX track;
 - o Further improvements and completion of irrigated turf event space:
 - o Improved walking and cycling paths; and
 - Improved connection / linkages to River Torrens Linear Park/Breakout Creek Stage 3.
- A Community Day was held on Saturday 28 August 2021 following which, a survey was available on Council's 'Your Say' page, in order to gather feedback on the next stage of proposed works.
- Positive feedback was received at the community day, and the main comments/feedback included:
 - Multiple requests to include adult fitness equipment on the site;
 - o Multiple requests to include a more advanced BMX track rather than only a junior track;
 - o Importance of a range of grades for BMX riders;
 - o Keep the natural look and feel of the site not too much hardstand surfaces; and
 - Additional car parking is required.
- A new dual accessible toilet facility will be installed at Apex Park soon after an alternative option for sewer connection (north of the carpark entrance).
- The on-ground works for this stage of works are to be completed by December 2022 in order to meet the conditions of the grant agreement.

Discussion

Following the Community Day held on 28 August 2021, a survey was available on the 'Your Say' platform to gather further feedback regarding the proposed upgrade. The survey was accessible until 24 September, and by the closing date, 58 responses were received. Of the respondents, over 57 per cent live in West Beach and interestingly, 23 per cent were aged under 29 years.

The online survey asked respondents whether they supported, somewhat supported or did not support the proposed improvements to Apex Park 60.7 per cent supported and 39.3 per cent somewhat supported the improvements. Not one respondent did not support the proposal.

Further, respondents were asked to identify their level of support to the key elements that make up the next staged upgrade of Apex Park. All key elements were overwhelmingly supported, however their priority order can be found below:

- Accessible path linking River Torrens and Breakout Creek; Viewing Decks to Wetland; Additional Park Furniture.
- 2. Nature Play Area; Northern edge wetland reformation.
- 3. BMX Area; Event Space.

Full details of the updated survey results are attached (Attachment 1 - under separate cover).

Following the public consultation period, all feedback gathered was provided to consultants in order to refine the draft concept plan for the next stage of the upgrade. The main changes made to the concept plan were level of difficulty and size of the BMX area proposed. It was evident from the feedback that young people require an intermediate level BMX area rather than a junior track. A larger space has therefore been designated to this element and it will be designed / constructed by an appropriate consultant / contractor.

The procurement process has commenced for the next stage of works, and tenders closed on 17 November 2021. A verbal update will be provided by the Administration at the meeting. It is expected work will commence early in 2022 and be complete by December 2022, as required by the grant funding conditions. The procurement process for this stage of works has been spilt into three packages of works - the packages include: civil / bulk earth works, landscaping and the BMX track.

A large number of requests were made through the consultation period to increase carparking on site. Unfortunately this element is not included in the next stage of works as carparking is not funded through the Open Space Grant. This element will require funding by Council in a future budget.

The public toilet facility funded through the Local Roads and Community Infrastructure Program is almost complete and is expected to be operational from the end of the month. The temporary facilities located at the entrance to the park will then be removed, making way for a new storage facility for the Girl Guides, Scouts and Lockleys Riding Club.

Climate Impact Considerations

(Assessment of likely positive or negative implications of this decision will assist Council and the West Torrens Community to build resilience and adapt to the challenges created by a changing climate.)

This project positively contributes to the climate change resilience of the local area.

Conclusion

A period of community consultation was undertaken to gather feedback regarding the next stage of works. Consultants analysed the data and used feedback to refine the concept plan.

The procurement process has commenced and work is expected to commence in February 2022.

Key observations:

- Food waste in organics bins from trial participants has increased by 366 per cent.
 - Baseline: food waste constituted 3 per cent of total green bin contents.
 - August: food waste constituted 14 per cent of total green bin contents.
- Food waste in general waste bins from trial participants has decreased by 60 per cent.
 - Baseline: food waste constituted 15 per cent of total red bin contents.
 - o August: food waste constituted 6 per cent of total red bin contents.
- The percentage of food waste from households not participating in the trial remains unchanged in red and green bins.

Q5 How often do you attend Apex Park?







Another addition to stage 2 potentially near the multi sport court at number 12 (or near the existing playground) would be two ping pong tables. The significance of ping pong tables is they can be used for people from 8 - 80 the playground is great for little kids but playground are notoriously boring for adults. Ping pong tables are in small parks all across Germany and are incredibly popular with the community where round robins are regularly played between neighbours of all ages. The Drakes could sell (or loan) the bats and balls and it gives people over 8 something to do in the vicinity of the playground. You need two though because one will always be full and the surface underneath the table should be crushed rock or Yankalilla sand rather than that spongy stuff in playgrounds that makes the ball bounce wildly. Secondly the existing POS on Burbridge Road is a problem. Drivers leaving the school don't look and people are regularly nearly hit. It also needs to be further west to cater for the peds going from the school to the day care. This may also be in Charles Sturt or even a DIT road but I think the whole T junction needs to be signalised now instead of a POS.

This log which side on faced East and on the Easten side of the island was an essential morning basking site for the resident colony of short necked turtles, it is not known what impact the stage 1 development had on the turtle population but I urge council to install a suitable replacement log for any surviving turtles to use, I ask council to replace a similar log as was removed during stage 1 I have counted up to 7 turtles utilising thie previous log for basking at one time during a morning. This former log was obviously placed for the specific use of the turtles and was used buy wetland birds as well. I also urge council to install birdboxes (eg faunature bird boxes)attached to trees throughout the park to provide artificial but Essential nesting sites for native birds. Thank you

Building a walkway across the river enables residents from Fulham to gain access to the reserve. It will also give easy access to their children to attend the West Beach Primary School. I point out, I attempted to have a similar bridge built across the river many years ago to give residents access to the reserve and their children an easy way to travel to West Beach Primary when the Fulham Primary School closed. Parking I raise a major concern over the lack of parking spaces that presently exists. When functions are held in the Community Centre (that replaced my "well-constructed Garth Palmer" Scouts Hall), the carpark is often completely full. There are no vacant spaces for families of children to park their cars in order to use the facilities on the reserve. The Park has been designed for residents to use, however, they are forced to park on the busy main road, often some distance away, as inadequate parking is available. This has the potential to restrict people using the reserve and its facilities. Lockleys Riding Club When we relocated the Lockleys Riding Club to West Beach, we assigned a closed lockable carpark area for the safety of children to protect them from moving horse floats. I am happy the Council Staff has assisted by leaving this area open when the Lockleys Riding Club is not holding events so that residents can park cars there, however, even with both car parks open parking is inadequate. I personally thank the Staff for meeting me on site to discuss the proposal. I expressed my concerns then. I believe an area on the vacant eastern section on the reserve should be earmarked for future carparking To exacerbate the problem, people attending functions held by the nearby Church also use carpark spaces that could be used by residents who want to engage in activities on the reserve. I am award this cannot be avoided, but unfortunately adds to the unsatisfactory parking situation.
