Due to copyright restrictions and the provisions of the *Development Act 1993* and Development Regulations 2008, public access to documents associated with development applications is restricted.

Documents associated with Development Applications can be viewed at Council's Civic Centre, 165 Sir Donald Bradman Drive, Hilton during office hours, Monday to Friday, 8:30am and 5pm.

Council is not required to make documents available for viewing or copying if, in the opinion of the Council, it will unreasonably jeopardise the present or future security of a building or constitute a breach of any other law. In addition to this, Council is not required to provide copies where it involves an infringement of copyright in matter contained in a document.

An application must be made to Council and consent granted from the copyright owner to allow Council to reproduce copies of the documents.

If you are not the holder of copyright for the documentation, under the *Copyright Act 1968* you must include written permission from the copyright holder, e.g. engineer, architect, building designer, builder.

Fees and charges – Please note that there is no charge to search documents for applications. If you are seeking copies of documents for applications the following fees will apply: up to three pages – no charge, A4 @ 20c per page, A3 @ 40c per page, A2 @ \$6.60 per page, A1 @ \$7.15 per page.

A Council staff member will be in contact with you to organise payment of any fees, if applicable.

No responsibility is taken by Council if, following all relevant searches, the requested documents cannot be located.
