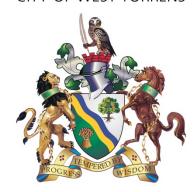

# 8.13 Richmond Oval - West Adelaide Football Club - Development of Masterplan (Brought Forward for Consideration at this Point of the Meeting)

Cr George Demetriou declared a perceived conflict of interest in this item as he is a Life Member of the Club and his daughter is a Board member of the West Adelaide Football Club, and participated in the discussion and vote.

This report provided Committee Members with information in relation to activities undertaken to date regarding the development of a building Masterplan for the West Adelaide Football Club and Richmond Oval.
