21.3 Planning, Development and Infrastructure Act: Anzac Highway, Glandore

On 1 July 2021 a Section 76 amendment to the Planning and Design Code was gazetted. Specifically, the amendment related to increasing the building height requirements in the Urban Corridor (Boulevard) Zone along Anzac Highway, Glandore. This report outlines the events that preceded the amendment and possible actions for Council to consider.

RECOMMENDATION

It is recommended to Council that it:

- 1. Awaits a response from the Minister for Planning on this matter in order to determine whether to commence a Code amendment to reduce the building height from 8 storeys to 3 storeys for the following parcels of land:
 - 118A Anzac Highway, Glandore
 - 130-132 Anzac Highway, Glandore
 - 144 Anzac Highway, Glandore
 - 158 Anzac Highway, Glandore
 - 186 Anzac Highway, Glandore
 - 188 Anzac Highway, Glandore
 - 2A Stuart Street, Glandore
 - 192 Anzac Highway, Glandore

OR

- 1. Initiates a Code amendment process immediately which seeks to reduce the building height of the following parcels of land from 8 storeys to 3 storeys:
 - 118A Anzac Highway, Glandore
 - 130-132 Anzac Highway, Glandore
 - 144 Anzac Highway, Glandore
 - 158 Anzac Highway, Glandore
 - 186 Anzac Highway, Glandore
 - 188 Anzac Highway, Glandore
 - 2A Stuart Street, Glandore
 - 192 Anzac Highway, Glandore
- 2. Requests the Minister to approve an early commencement of this Code amendment to ensure that 8 storey development is not facilitated on these allotments during the Code amendment process.
- 3. Allocates \$50,000 for the costs associated with undertaking this Code amendment.

- 144 Anzac Highway, Glandore
- 158 Anzac Highway, Glandore
- 186 Anzac Highway, Glandore
- 188 Anzac Highway, Glandore
- 2A Stuart Street, Glandore
- 192 Anzac Highway, Glandore
- 2. Requests the Minister to approve an early commencement of this Code amendment to ensure that 8 level development is not facilitated on these allotments during the Code amendment process.
- 3. Allocates \$50,000 for the costs associated with undertaking this Code amendment.
- 4. Seeks to recover the cost of the Code amendment from the State Government.

- 2. Council delegates the power of review, but not the extension, of the confidential order to the Chief Executive Officer on a monthly basis in accordance with the provisions of Section 91(9)(c) of the *Local Government Act 1999*.
