## 3.1 AFC Masterplan Update

Ashley Connolly Is the access to the Meyer Street carpark through Ashley Street or can it be accessed from the South Road entry?	AFC - access to Meyer Street carpark is as per the existing arrangements via the back of Thebarton Senior College behind the existing SANFL facility with the entrance through Ashley Street and continuing on to get into Meyer Street. As per the MAG purpose and Objectives, there will be no public vehicle access to the Precinct from Meyer Street except for emergency vehicle requirements only.	Nil
Cr John Woodward Is the intention ultimately for AFC to expand the Kings Reserve Oval into the south-west corner, is that your hope and aspiration?	AFC - yes that would be the aspiration but we are unable to commit to that.	Nil
Cr John Woodward AFC has previously indicated no interest in the land located on the south-east corner, adjacent to the Thebarton Oval, is that still correct?	AFC – correct	Nil
Cr Graham Nitschke - Will reports, specifically a detailed Traffic and Parking report be provided with the report for Community Consultation?	AFC - the traffic modelling is undertaken and generally provided at the time of the development application assessment. It would be risky for the Club to spend significant funds on the traffic reports prior to the masterplan endorsement. The traffic engineering consultants have advised throughout the processes that the access arrangements for Thebarton Oval Precinct are suitable.  AFC is currently seeking Council endorsement of masterplan to go out for public consultation.	CWT/AFC - to be provided during DA assessment
Cr Graham Nitschke - No mention is made regarding what may occur when the temporary DIT acquisition of Kings Reserve next to the community Centre is handed back. What is the latest regarding this?	Already answered by Mayor Coxon.	Nil

Cr Graham Nitschke - Is there still going to be a bus drop off point between where the Community Centre was and Kings Reserve?	AFC - continuing to consult with DIT on including a bus drop off area adjacent to the South Road access for game day drop off and pick up.	AFC
Cr Graham Nitschke In reference to the Tree Strategy on Slide 13 of the AFC presentation, 2 x regulated & 2 x significant trees are being removed where the north-east section of the 3-storey building is planned. Has any consideration been given to moving that section of the 3-storey building to where the 1 and 2 storey section of main building is, in an effort to retain those regulated and significant trees?	AFC - there are functionality requirements that need to be considered for the training and admin facility, otherwise the project is not feasible. The updated masterplan and building configuration - achieves increased significant or regulated tree retention of 3 trees as well as increased tree retention of 58 total trees compared to previously presented masterplan.	Nil
Cr Graham Nitschke In reference to the Tree Strategy on Slide 13 of the AFC presentation, how deep is the Residential buffer along Ashley Street [for the group of trees located in that area]? As per my request on 2 July 'Raised mound and dense landscaping 10 metres deep on Ashley street as a sound and vision buffer for Ashley Street residents'	AFC - it is in the order of 10m between the edge of the oval and the street. Behind the goals there is an embankment which is bordered by a retaining wall so that offers an extensive sound buffer from the actual field of play.  Corridor trees are being proposed along that strip which are tall with a large canopy. It may also include eucalyptus trees as they work well in that location.	Nil
Cr Graham Nitschke Are current footpaths and Street trees along Ashley Street unaffected?	AFC - they will be maintained where the footpath alignment is located.	Nil
Cr Graham Nitschke - In reference to the car parking on Slide 15 of the AFC presentation, sought clarification on the north- west parking area as being used during non-match days while on match days it will be emergency services only.  Sought clarification on the 160 spaces figure for car park availability at AFC facility	AFC - on match days, the car park will probably be used as an area for food trucks which community and game day attendees can enjoy, no cars going in/out of that location for parking.  In terms of the 160 spaces, there will be 136 spaces in the south-eastern carpark entirely dedicated to the AFC staff and 46 spaces on the south-west that will be shared between AFC and public, and that makes up the 160.	Nil
Ashley Connolly How many car parks on Meyer Street carpark and whether there will be access to the carpark during training days.	AFC - existing Meyer Street parking is 43 parks. Access to the north-western carpark is all via the existing access behind the existing facility so it's off Ashley Street. There is a roadway that goes into the carpark, there will be no access via Meyer Street.	Nil

Cr Graham Nitschke - In reference to the AFC Masterplan Report, it states that: "The south-west, north-west, and north-east car-parking areas are publicly accessible" - What about the south-east carpark?	AFC - reiterated that the south-east carpark is dedicated to the AFC staff. The modelling undertaken with the Traffic Engineer and the Sustainability Consultant has indicated that the 160 spaces in accurate for peak demand.	Nil
Cr John Woodward Sought confirmation that AFC has no interest in having pokie machines on the facility.	AFC - correct, no pokie machines.	Nil
Cr John Woodward Sought confirmation from AFC on the purpose of the training and admin facility, specifically that AFC do not expect people to come to the venue following games.	AFC - correct, Adelaide Oval is a great home game venue and people tend to remain in the CBD following matches so this facility will not be an after-match venue.	Nil
Cr John Woodward Commented on the trees strategy and requested consideration of planting 1:3 trees within the lease area.	Noted.	Nil
Cr John Woodward With regard to Stage 2 of the project, requested consideration of community consultation being undertaken irrespective of the landowner.	Noted.	
Cr John Woodward Sought clarification on whether the updated masterplan is what will be considered by Council for endorsement to go out to public consultation, noting the questions raised during the meeting about the proposed lease line.	Mayor Michael Coxon advised that the proposed lease line matter will need to be clarified prior to the masterplan being presented to Council for consideration on whether it should be endorsed for public consultation. Ashley Connolly As per Slide 5 of the PP presentation, do the AFC intent on playing any men's or non AFLW games at TO (outside of gather round)?	AFC - at the moment, have an agreement with SANFL that AFC cannot play any home games until the end of 2028 which is a contract that we've had for 15 years. If we were to consider that, it would have to fit within the user agreement signed with Council.	Nil
Ashley Connolly - slide re As per Slide 6 of the PP presentation, there is community concern about the increased footprint of the AFC HQ and carpark, is this a climate smart design and is there any opportunity to reduce the footprint and	AFC - referencing the right image on Slide 6 of the PP presentation, the eastern position for the AFC training and admin facility means that it does not demolish any of the buildings on the western edge, it will repurpose one of the buildings which is currently used as a function centre and build on top of it by one level which retains all of its carbon embodied energy within that building. This was encouraged by the AFC sustainability consultants.	Nil
some of the carparks to make it less of a 'heat sink'?	Moving the facility to the east, AFC have been able to reduce the height of the facility, the indoor training facility has now been positioned centrally to the eastern facility. The south-western carparking area is shared and should not be included in the calculations but acknowledge that the south-eastern carpark is the AFC carpark that was originally intended to be undercroft on the western facility but due to height and visual impacts it has now been reduced and split it out of the building, shown as grey on the plan. The carpark will have trees through it, permeable paving and of material that achieves green star rating and reduces the heat island impact.	

	Whilst we acknowledge that the footprint is perhaps larger, it retains all existing western buildings and is a much smarter way of dealing with the issues that it solves by locating it on the east.  City Collective have undertaken an extensive user group consultation process with AFC around the functional requirements and that have been translated into the two-storey building that meets the functional requirements of AFC. The green 5-star requirements have also been taken into consideration.	
Cr John Woodward The floor area of the two options on Slide 6, are they significantly different, acknowledging one is 4-storey and one is 2-storey?	AFC - no, they are very comparable.	Nil
Ashley Connolly Is it possible to save the 8 trees shown on Slide 8 of the PP presentation, particularly the 4 significant and regulated trees in the south- east corner being removed from the carpark if they are not interfering with the building process.	Community concerns noted, refer to above two points above.	Nil
Ashley Connolly Queried whether green carparks as per Slide 9 of the PP presentation were possible?  Douglas Schirripa commented, from personal experience, that parking a vehicle on grass daily in 12months it will result on the area being a dust bowl with no grass.	AFC - unfortunately, AFC is bound by the Australian Standards which requires line marking and surfaces be of certain material etc. and any formalised carpark cannot be grass. As a compromise, AFC will provide permeable paving in appropriate areas to allow for landscaping to occur within a hard surface and ability to capture run off from stormwater, lower the amount of hard material and reduce the heat island effect. Ashley Connolly As per Slide 10 of the PP Presentation, noted community concern about oval maintenance, with reference to the West Coast Eagles turf renovation.	AFC - there is no fixed time of the year when the turf will undergo maintenance, however, we do not expect to have a maintenance program that is anywhere near as onerous as the West Coast facility, purely by function of how Kings Reserve will perform. It will be a training oval and will have cars parked on it during game days.	Nil
<ul> <li>When will oval irrigation/ maintenance occur?</li> <li>Will residents be locked out of KR oval for extended periods each year?</li> </ul>	In terms of sprinklers, generally sprinkling is done at night due to the lower evaporation compared to daytime sprinkling. AFC will work with Council in terms of programming of sprinkling to be done outside of hours that community will typically use the space.	

Sought clarification on whether the surface on Thebarton Oval will be slightly different to the surface on Kings Reserve.	The intention is to have the same turf on both the Thebarton Oval and Kings Reserve. AFLW games will predominantly be played on Thebarton Oval, it is a fact that they are not turned up as much as Ovals that have men playing games on them. West Coast Eagles have varied grade of leagues playing on their oval and thus a far more intensive oval maintenance program.	
Ashley Connolly As per Slide 11 of the PP presentation, commented that community have requested to be informed about Stage 2 during the upcoming community consultation.	Noted.	AFC/CWT
Ashley Connolly As per Slide 12 of the PP presentation, noted the community understanding and expectations in terms of the tree strategy with preference for planting of large trees with greater canopy cover and shade, and not dwarf/semi-dwarf trees.	AFC - effectively this is a regional level park and planting ornamental trees is not something Council would want to see here and certainly not what AFC are proposing.  The trees that are removed will be replaced with native and where possible endemic trees to encourage biodiversity and build the fauna within Kings Reserve and Thebarton Oval.  There will be creation of different 'zones' of character types within the masterplan, defining pedestrian paths with big trees and big canopy to provide that shade to frame up the Avenue. Ashwin Parade trees to define edge of the parks so people know you are there. This will end up being somewhat of a woodland forest particularly in the Kings Reserve community space. The realities of that might change with the guidance of the community but that is how we see our strategy working out.  Certainly, European species are on the list and promoting Australian native trees and where possible endemic trees.  AFC has committed to plant 220 new trees within the Thebarton Oval precinct and that includes community land which might be sometime after the main development occurs.	AFC
Ashley Connolly Noted of confusion about how it might work from a gaming point of view, are we going to have people roaming the streets based on liquor licences extending and all that stuff.	AFC - there is an existing liquor licence for Thebarton Oval catering for 9000 people that SANFL hold. There is no change to the liquor licencing as it's already been approved for the site.	Nil

Merryn Cossey Sought clarification on the State Government funding, will there be additional \$10M over and above the \$15M that they are committing to AFC for the TOP project, specifically for community greening space as a result of the disruption due to DIT works.	Confirmed.	Nil
Merryn Cossey Sought clarification on whether there will be an additional consultation period with the community if the State Government returns land to Council that is not currently subject to the lease that is going to go to AFC	Mayor Coxon - if the State Government returns to Council part of the land that they have temporarily acquired for the T2D project, then Council will need to go through the statutory process of negotiating a lease etc. for that period of time. The State Government may choose not to return the land to Council and may choose to directly consult with AFC.	Nil

#### Cr Nitschke requested that the meeting notes of 31 January 2023 be updated to include the Masterplan Design Objectives as listed below:

### **Masterplan Design Objectives:**

- Previously agreed elements of the 2018 Kings Reserve Masterplan are to be incorporated into the Precinct Masterplan;
- Removal of significant and regulated trees is to be kept to a minimum and where such trees are to be removed, for each such tree removed three new trees are to be planted within or close proximity to the Precinct;
- Where possible, replacement community facilities are to be constructed and made available prior to existing facilities being demolished or closed;
- That the replacement community Centre remain Council run and independent to AFC;
- That direct traffic access to the Precinct from surrounding residential streets shall be minimized where possible but there shall be no public access to the Precinct from Meyer Street unless for emergency vehicle requirements;
- That any proposed development improves upon existing parking infrastructure and that parking remains free and available to residents other than on game days;
- Public parking levels meet planning requirements and AFC provide their full car parking requirements specific to their needs as part of the development, with the understanding game day will require temporary parking arrangements;
- That artificial turf not be used for external sports fields:
- Public access to green space on Kings Reserve and Thebarton Oval is to be maximized during daylight hours and where possible, use of both ovals at the same time during daylight hours by AFC is to be minimized with AFC sole access times of both ovals to be made publicly available;
- Council and AFC will meet and coordinate Precinct usage at least annually so as to ensure there is no prohibition of community events or festivals on Kings Reserve due to AFC requirements;
- There are no restrictions to dogs and dog walking on Kings Reserve during public access times.
